Ralph De Palma, won the fifth annual 500 mile automobile race at Indianapolis, Decoration Day, breaking all records for the distance. He took the lead just before the 200 mile mark was passed and held it practically all the rest of the distance.

His time for the 500 miles was 5:33:55.50, an average speed of 89.94 miles an hour. Rene Thomas, who won last year, averaged 82.47 miles an hour.

#### Why Many Moving Picture Films Are Crude.

The Woman's Home Companion is conducting a campaign for better moving pictures. Each month its editors in New York are examining hundreds of films and each month they recommend to their readers the best. In this month's Companion about one hundred films are recommended and an article accompanies the list entitled, "How Better Films Are Selected," in the course of which the writer comments in part as follows on the imperfection of certain films and the reasons therefor:

"Violations of common sense are too frequent. The hero's hair turned white following a thrilling adventure, which transformation was too much for the credulity of a twelve-year-old, who required the assistance of an indignant usher to quiet his discovery.

"A slender office clerk, unarmed, beat up a trio of big, burley, armed thugs and saved the cash drawer. The murderer at bay, in another picture, picked off a dozen policemen, straight shooting without reloading his revolver. It is too much to expect picture audiences to find such pictures entertaining. Life is too full of real dramatic sensation.

The director has his troubles, however. The story, no matter how long or how short, must be made exactly into five hundred or a thousand feet of film. The result is a congestion of plot, omitting necessary detail, so that grotesque impressions arouse the spectators' ridicule or criticism, or the padding with unessential details to make the required length encourage a yawn.

"The producer says this condition is necessary because the public demands a daily change of pictures, which in turn demands a mechanical distribution, and this necessitates a mechanical production."
