## Midnight Prowlers Get Little Plunder.

Robbers entered the North Side hardware store some time during the night and also the C. O. D. cleaning establishment and the Blalock feed store. They succeeded in getting very little plunder so far as can be discovered, although they broke open the money drawers and the cash register in the C. O. D. establishment.

They made entrance to the hardware store through the back door with a file. Four revolvers were taken and four razors and a few shells and other small articles. They tore open the desk and broke into the money box, but it contained nothing but papers. They also broke the money drawer with a hatchet, but there was very little in it and they took nothing. The drawer contained only a few pennies and some trade chips on the North Side grocery.

In the cleaners they pried open the cash register and took \$20.40 which had been left. The register is bent out of shape and will need repairing. They also broke it up in several places. They tapped the money drawer of the Blalock feed store and tore it down in getting in, but it contained nothing. Entrance was gained through a rear window and it is thought that they opened it during the day, as it has always been kept locked. They left a knife which they had taken from the hardware store on the floor near the cash register in the cleaning establishment.

No clew as to the identity of the robbers is had with the exception of the hardware they took, which can be identified.

Edward Thompson left yesterday morning for Chappell where he will make an extended visit with his brother Hilmer Thompson, formerly of this city.



Automobile tourists are passing through in goodly numbers, the average for this week being a half dozen cars a day. As the season advances the number will increase.

The little son of Mr. and Mrs. Larkin Cecil, residing on West Tenth street, fell Thursday evening and broke his arm. Both bones in his right forearm were broken. Medical attention was summoned and he is reported getting nicely.

The North Side Pirates defeated the round house team Wednesday evening at the round house base ball diamonds by the score of 3 to 1. The game was fast and exciting and there was not an error on either side. The first five innings of the game was marked with no runs and only one hit. Suit was filed last evening in the county court by Maurice J. O'Connell against Thomas J. Long for the collection of a reward of \$25 which the plaintiff alleges was offered by the defendant for the conviction of parties furnishing liquor to his son, Ed. J. Long. Plaintiff alleges that he knew of the public offer and went to work with the intention of convicting the guilty parties and succeeded in convicting Will and Joe Hunt in Justice I. L. He prays for the reward of \$25 and the costs of the suit. The offer was made publicly about January 31, 1914, and the two men were convicted in February.
