Notice to Non-Resident Defendants

Alvin E. Rogers and Fannie E. Rogers, his wife, defendants, will take notice that on the 11th day of January, 1915, Charles B. Rogers, plaintiff herein, filed his petition in the District Court of Lincoln County, Nebraska, against said defendants, the object and prayer of which are to quiet his title upon the South half (S¹/₂) of the South-west quarter (SW¹/₄) and the South half (S¹/₂) of the Southeast quarter (SE¹/₄) of Section twelve (12), Township nine (9), Range twenty-eight (28), Lincoln County, Nebraska, against the defendants Alvin E. Rogers and Fannie E. Rogers, his wife, who are claiming an interest in and to the above described premises by reason of a defective foreclosure, wherein Lincoln County brought a tax foreclosure suit against Alvin E. Rogers and wife for taxes due upon said premises, and said Lincoln County took a default judgment against said defendants prematurely, and that said premises were sold to P. A. Hammond, and that the said Alvin E. Rogers made application to redeem from said tax sale and notice of said application was served upon the said P. A.
