### ASKS \$25,000 FOR ALIENATION OF AFFECTION.

Jasper O. Mahaffey filed his petition in the district court Tuesday afternoon in a suit against John T. Stuart and his wife Frankie Stuart for \$25,000 damages for the alienation of his wife's affection. The petition recites that Mahaffey married Miss Irene Stuart in Denver October 27th, that they went to Omaha immediately thereafter where he furnished her support and care. That after the marriage his wife was satisfied; that she was a kind, loving and devoted wife and that they enjoyed each other's society.

It is alleged that the defendants, the parents of his wife, were opposed to the marriage, and that they spoke disrespectful of him, and tried to dissuade, prejudice and alienate his wife's affections from him. On November 21st his wife came to North Platte to visit her parents and they continued to speak disrespectful of him and to prejudice his wife and incite her against him and that finally on December 29th, while he was away from Omaha his wife removed her personal effects from his home and returned to her parents, since which time she has not communicated with him and has failed to return to his home.

Thus deprived of the comforts of home and the society of his wife he asks the court to award him damages in the amount of twenty-five thousand dollars.

Shipping in Laborers

The Omaha Bee is authority for the statement that one hundred men will be sent from that city to North Platte this evening to work on the ice harvest, or rather at the Union Pacific ice houses.
