terests of the state are not being safe guarded. The administration is likely to be hampered by the advocates of state rights, who will put up against any advantage being given to Japan in the hope that some other concession may be made in return.

Salem, Or., Feb. 6.—Hunters will continue to pay license in Oregon, but anglers will not have to this year. Bills for the repeal of the hunters' license and for establishing an anglers' license of \$1 came up in the senate this morning and both were defeated. The Oregon Fish and Game association fought the repeal of the one and proposed the other, so it has a victory and a defeat to its credit. Senate bill 91, to create a commission to establish and operate state game and fish hatcheries was also killed. It was doomed when the anglers' license failed, as the money from the license was to support the hatchery as planned by the state association. Vice-President W. P. Andrus, of Hood river, has been here lobbying for the passage of the anglers' license bill. The state association has centered most of its strength on that bill this year, and will have another up before the next legislature. Mr. Andrus talked of establishing at least three hatcheries in the state and of devoting them chiefly to the propagation of trout.

At Kings Valley.
There was a meeting of farmers at Kings Valley yesterday, to talk railroad. Some have hopes that the Southern Pacific will extend their road from Airlie. The meeting was called at the suggestion of Joe H. Harberg of the Lude, endence and Dallas railroad. A committee was appointed to list the probable products and other business for a road here.

A canvasser from the Corvallis creamery is in the Valley in the interest of the creamery.
Kings Valley could and would produce lots of cream if the farmers would turn their attention in that direction, but the distance to a R. R. station is a difficulty that has so far kept them from trying it.

Some Odd Wills.
