TOUGHS FROM 'HELL'S BOTTOM.'

George Wells Stabs Charles Watson—The Result of Gambling. Two colored "toughs" from Hell's Bottom, known as George Wells and Charles Watson, got into a quarrel in Keith Sutherland's saloon, corner of R and Twelfth streets, last night.

The keeper of the place ordered them out, and after getting on the street they continued to wrangle, during which Watson was severely stabbed with an ordinary pocket-knife. George Smith, who was a witness of the row, saw George Wells deliberately close the knife and put it in his pocket after the occurrence, and then walk away.

Officer Grant was summoned to the scene of the assault and immediately ordered the patrol wagon from the Second precinct and had the injured man sent to the Freedman's Hospital. An examination of Watson showed that he had received a dangerous stab just below the left nipple. It was thought at first that the cut would cause almost instant death, and although the man's condition is critical to day, it is thought that he will recover.

Some hours after the assault Wells gave himself up to Officer Grant. It appears that there has been bad blood between Watson and Wells for some time over a gambling transaction and they have had repeated quarrels. They are both well known to the officers and are said to be bad characters. Wells claims that he did the stabbing in self-defense and that he was provoked. Watson was going to shoot him, as he had often threatened to do so. Wells is held at the Second Precinct Station awaiting the result of Watson's injuries.
