MR. MCKINLEY PRESENTS A SILVER RESOLUTION

LOOKING TO GAGGING OF DEMOCRATS

Mr. Blount Speaks in Defense of Minority Rights.

HISCOCK TALKS FREE IN THE SENATE.

The Conference Committee Agree on the City Postoffice Site—Other Congressional Affairs.

In the House this morning Mr. McKinley reported a resolution providing that the House shall proceed immediately to consider the Silver bill, and that consideration shall continue until 3 p. m. Saturday, when the previous question shall be considered as ordered.

The previous question was ordered on the resolution and forty minutes' debate was allowed. Mr. Blount of Georgia had no objection to the limit set for debate, but he was informed that the chairman of the Committee on Coinage, Weights and Measures would be allowed to offer all the amendments which were admissible under the rules of the House.

When these were offered there would be no opportunity for the minority to offer amendments, nor would the minority have a chance to ask the House to vote on free coinage. This proceeding Mr. Blount characterized as a wicked, shameful outrage on the minority.

Mr. Cannon of Illinois said that the minority could offer any amendment that they could under the general rules. Mr. Springer of Illinois said no amendment was to be offered to the bill, except such as were suggested by the chairman of the committee.

HE DENOUNCED THE ACTION

as intended to prevent the representatives of the people carrying out the will of the people.

Mr. Williams of Illinois said the resolution adopted yesterday was a majority from legislation. He appealed to members of the other side who favored free coinage to stand by the interests of their people.

Mr. McKimley said that the resolution was intended to give the House an opportunity to pass some silver legislation which would be in perfect response to the general sentiment of the country.

After more discussion the resolution was adopted—yeas 120, nays 117. Mr. Blount voted in the affirmative and moved a reconsideration.

The Republicans who voted in the negative are: Messrs Anderson of Kansas, Hastings of Iowa, De Haven of Featherstone, Funston, Kelly, Morrow, Hermann and Townsend of Colorado. No Democrats voted in the affirmative. The motion to reconsider was tabled—yeas 104, nays 118.

In the Senate

The Senate immediately after routine business this morning took up the Silver bill, and Mr. Hiscock took the floor. He believed that a majority of the people were opposed to opening the mints of the world's silver by the free coinage of the world's silver.

When Mr. Hiscock had concluded Mr. Sherman took the floor.

The City Postoffice

The conference committee of the two Houses met yesterday and agreed to purchase as the site for the city postoffice the square facing the avenue on the south and between Eleventh and Twelfth and C streets. The report is in preparation, and a bill is being drawn. It will include a condemnation bill which will probably be completed and reported to the two Houses to-morrow.

He Counted a Quorum

Yesterday afternoon late the Democrats refrained from voting on a concurrent resolution directing the enrolling clerk to include in the Customs Administration bill a Senate amendment relating to the abandonment of goods to underwriters and sailors. They were not opposed to the resolution, but refrained from voting to compel the Speaker to count a quorum. They, therefore, insisted on the yeas and nays, and then declared a quorum, and declared the resolution adopted—yeas 127, nays to 3.
