TRAIN APPLICANTS FOR CITIZENSHIP

Y. M. C. A. to Give Free Course to All Candidates for Naturalization.

A free course in citizenship for all men expecting to take out their final papers is to be given at the Y. M. C. A., 1317 Broadway, West and Second street.

At this time of the year there are many men who are planning to take out their second papers, and become fully naturalized citizens of the United States.

The course of instruction is based upon the outline furnished by the United States government, and is approved by the naturalization officials of the city.

Beginning Friday night, May 19, at 7:30 p. m., two lessons a week will be given for three or four weeks, so that those intending to get their papers at the next examination day will be able to do so.

The course will cover all the required work on which the examinations will be based. A simple but thorough presentation will be made of the government of city, county, state and nation.

Before a man becomes a citizen of the United States he should be able to understand, speak and write our language, understand our system of government and the spirit of our institutions.

This course at the Y. M. C. A. is intended to help a man become a better citizen. Every one is welcome, and the course is free.

BOSTON, May 11.—A. F. of L. Federal Labor unions of Millhook, East Millinocket and Madison, Maine, have secured a union shop agreement with the Great Northern Paper company. Wage increases average about 15 per cent and the contract will continue for three years.

At conference between the Woodland Federal Labor union and the St. Croix company wages were increased to about 9 per cent and a union shop agreement, to run three years, was secured. These contracts will begin and expire on the same date as the Stationary Firemen's union and the papermakers' union.
