COLVER WANTS TO KNOW WHO OWNS STOCK YARDS

WASHINGTON, March 11.—Federal Trade Commissioner Colver told the house agricultural committee that it was impossible to find who owns or controls the Chicago stock yards, which are covered up by numerous devices. He said these properties are owned under certificates in black payment to bearer, and that under this system the packers can evade the recent agreement between them and the United States department of justice, by which they are to confine themselves to packing and produce business. Mr. Colver said existing laws were inadequate to deal with the industry.
