

GOVERNMENT BOARD FLOATED BY PENNSYLVANIA RAILROAD

Chicago, Sept. 15.—The Pennsylvania railroad notified the United States railroad labor board that it will not obey its orders that a fair election for representatives of employees on that railroad be held.

Each law, which provides in Section 301: "It shall be the duty of all carriers and their officers, employees and agents to exert every reasonable effort and adopt every available means to avoid any interruption to the operation of any carrier growing out of any dispute between the carrier and the employees or subordinate officials thereof."

On receipt of this order to hold a new election, the Pennsylvania railroad asked for an extension of time. This was granted by the board, which is now informed that its order will be disregarded.
