LAW OF MARYLAND. PUBLIC LOCAL (OFFICIAL)

An Act to endow the St. Mary's Female Seminary.

Whereas, in the year eighteen hundred and thirty-nine, the Legislature of the State of Maryland, considered that, whereas, the disposition to cherish the remembrance of great events and sacred places, as connected with the early history of our ancestors, has ever been in all ages of the world considered praiseworthy and commendable...

Section 1. Be it enacted by the General Assembly of Maryland, That the Governor of Maryland, by and with the advice and consent of the Senate shall biennially appoint a commissioner of fire wood for Leonardtown, who shall reside in said town whose duty it shall be when called upon by any seller or purchaser of firewood to measure greater than five cords of firewood to measure the same.

Section 2. And be it enacted, That said wood order for each cord of firewood he may measure under the provisions of this Act, shall be allowed five cents, to be paid in all cases by the purchaser, and on his neglect or refusal to pay the same, the wood order may collect it as other debts.
