STATE OF MARYLAND. Treasury Department. COMPTROLLER'S OFFICE. Annapolis, October 6th, 1871.

In compliance with Section 6, Article 69, Code Public General Law, to wit:

"The Comptroller shall furnish each officer of the State whose accounts are in arrears at least thirty days prior to a general election, a full statement of the accounts, and in default of his accounting for such deficiencies within thirty days, then it shall be the duty of the Comptroller to have published weekly for one month, in one or more newspapers in the several counties of the State and the city of Baltimore, the names and titles of said officers, with the amount of such deficiencies."
