The market for Southern white has ruled active and firm, and prices have advanced fully 3 cents per bushel, but below 1 cent firm, and we note a decline of 16 1/2 cents. The sales were 23,000 bushels white at 67 1/2 cents, and 23,000 bushels yellow at 62 1/2 cents, closing at 72 cents for white and 67 1/2 cents for yellow.

For Western the market has ruled quiet and somewhat dull. A large portion of the receipts had been sold to arrive, and the demand for shipment was limited. The sales reported were 3,000 bushels mixed at 64 1/2 cents, 1,200 bushels low mixed and yellow at 64 cents, and 1,000 bushels No. 2 mixed at 64 cents, all in elevator, and 1,000 bushels mixed on track at 63 cents.

Oats.—The market for Oats has ruled quiet and the tendency of prices has been in buyers' favor, but the market closes steadily at a decline of 1 1/2 cents per bushel. The sales reported amount to 20,000 bushels, and embrace 7,000 bushels mixed Western at 49 1/2 cents, 4,000 bright do. at 51 1/2 cents, the bulk of the latter at 51 1/2 cents. At the close we quote mixed Western at 49 1/2 cents, bright do. at 51 1/2 cents, and Southern at 51 1/2 cents. Through choice bright Southern would bring 56 cents.

Hay.—The market is steady, with moderate demand, and we are without change in price to report. We note a sale of 4,000 bushels prime Western at 101 cents, and sales in lots amounting to 1,000 to 1,200 bushels, at 95 to 100 cents for fair to prime Pennsylvanian and Maryland. Tobacco.—The receipts of leaf Tobacco continue liberal, and we note an increase in the inspection of this week of 300 lbs., the excess being in Maryland. The market for this description is active, and samples offering are readily taken at fair prices, principally for the French and German markets. As before reported the better qualities are relatively higher in value. We are still without movement in Ohio to report, the French buyers not having entered the market, and prices for all descriptions are steady. The exports for the week were only 424 lbs., of which 397 lbs. went to Bordeaux, to the 10th of May, and 27 lbs. to St. Lucia. We quote prices as follows, viz:

We note a fair supply of Virginia leaf Tobacco in the market, and are selling at \$80 per ton of 2,000 lbs. currency, but there is no stock in agents' hands. Gunpowder is quoted at \$10 per cwt. and \$10 to \$15 per ton for lots from 50 to 100 tons. There is an active Southern trade demand for Fertilizers, and the leading makers command \$40 to \$50 per ton, while inferior kinds are much lower.
