SENATOR GORMAN'S SPEECH

Senator Gorman declared that if the amendment should be successful he would agree never to seek place and would die a happy man.

His speech was as follows: "White men know that government by the people can only be secured through parties. I have great respect for every man who adheres to his party. Honest conviction and honesty in action constitute the main-springs of our Anglo-Saxon life. If we belong to parties we ought, then two great parties are absolutely necessary to secure a good government and the best of our institutions. I have always believed that in the hour of danger, in the time of great activity between parties the man who fails to respond to the rollcall on the eve of battle is not of much account in American politics. But every man must fix his own standard.

"I want to say until I came here today I had not the slightest idea that any man in Maryland would doubt that I am heartily in favor of this constitutional amendment. But my friend, Joshua W. Miles, told me this morning that the Republicans and the 'mugwumps' are saying so frequently that this is my amendment that the Democrats begin to doubt if I am taking any part for it. But never believe what the Republicans say about me, if you please.

"I could not help being impressed while I heard this convention addressed by a lineal descendant of the great Carroll who signed the Declaration of Independence. He lives in the same manor house in which his distinguished ancestor resided. His life is almost spent, as he has lived more than three-score years. He has no object personal to himself to subservise and has no desire for political preferment. He has only a desire to render service to his beloved State, and that brought him here today. He is acting as a patriot and for patriotic purposes only.

"My first activity in political affairs in this State was in association with Governor Carroll, who was the leading man in Howard county, a man of great reputation and great estates. He called upon the young men—of whom I was one in 1866—to put on the armor and fight against Republican proscription of white men in the State. He and I represented our county in the Legislature during the time of the infamous proceedings which culminated in forcing upon an unwilling people the Fifteenth Amendment, which gave us negro suffrage. Both of us voted against it.

"Since then it has been my good fortune, having been honored by the people of Maryland, to follow the same question in its different phases in the Congress of the United States and to raise my voice, to give my time and energy and all that was in me to lift the burden of brutal negro suffrage from the necks of the Southern people. I am proud of it. "I use the expression of Henry Winter Davis, with whom I differed politically as widely as the poles, when, denounced by the Maryland Legislature, he said: "I consider it a decoration of honor. I so consider the abuse of Republicans and 'mugwumps' when they denounce me for joining you in an endeavor to lift the black pall which hangs over our fair State. I do not know a man in the Republican party, from Secretary Bonaparte down, or from Secretary Bonaparte upward, I should say, because he is the last, who can understand how it is possible for a man placed in public position by the will of his party to stand with his party without hope of reward or desire for it.

"I have been fighting this same struggle under various conditions during the last 40 years, and I say now that if in November next we can lift, as I believe we will, this pall from the State and restore to the intelligent white men the untrammelled right to control our own affairs, I will agree never to seek place and die a happy man. But I promise this, if life and health be spared, that if by any corrupt combination with disaffected Democrats and reformers the negroes and their white Republican allies should defeat us in this election I am still a soldier and will fight on. The French have a proverb that 'everything comes to him who waits.' But as white men never surrender, but always fight for their liberty and their manhood, we will fight until there is not one left to accomplish an object so necessary for the welfare of the State. I am with you for that as long as I live."

Free Training of Nurses.

By the terms of a fund to be administered in connection with the Philadelphia School for Nurses, Witherspoon Building, Philadelphia, a number of young women from every county will receive free training in Nursing. It is planned to ultimately reach and help in this way every village and township.

The young women will be provided with room, board, nurse uniforms and all the refinements of a well-appointed Christian home. At graduation the diploma of the School and the Order of the Red Cross will be conferred, qualifying for practice in any State or country; the railroad fare will then be paid back home.

Those applying and chosen to receive the benefits of this fund will be given two years' training, with a rich experience in nursing the sick poor of the city under skilled leaders. The term may be shortened to eighteen months by taking a preliminary course of six months' reading and study at home. A special short course enables young women to quickly qualify themselves for self support and a substantial income.

In addition to regular nursing, the young women are taught how to preserve their own health; how to recognize, avoid and destroy contagion; how to establish and maintain perfect sanitary conditions about the home; they are prepared for positions as office nurse and physician's assistant; they get a practical knowledge of City Mission movements, Deaconess training, College settlement work, and are trained for special positions of trust in institutions.

The school is ten years old and is endorsed by physicians, leading educators and prominent men throughout the country.
