Jamestown.
In view of the Jamestown Ex-
position, it was deemed necessary to
again organize an Exposition Trav-
ellers' Aid Society. This was done
with headquarters in New York.
A number of Baltimore women
who work for women and girls also
banded together, forming the Mary-
land Committee of the Exposition
Travellers' Aid Society. They plan-
ned to have large placards placed
in railroad stations, boat land-
ings, on boats and in many other
places as possible in the City,
to invite the co-operation of the rail-
road and steamboat matrons and
other officials and to have agents
meet the boats arriving from Norfolk
who would care for girls and women
travelling alone. This plan is being
carried out. Outside of Baltimore
it was desired to form smaller com-
mittees whose duty would be to re-
ceive the placards and other litera-
ture, watch the local press for ad-
vertisements that might need inves-
tigation, report the same to head-
quarters and generally guard the
girls of their own community, who,
for work or pleasure, might be going
from home.
A circular letter was prepared and
sent out and the Committee has
received the co-operation of 67 ladies
in 55 towns in Maryland. There
are on the list 108 towns, so a num-
ber are still unprotected and the
Committee would be very grateful
to any lady who would offer her ser-
vices.
One agent was employed who during
the month of May met 68 boats,
finding 37 cases needing her care
and many others to whom she could
give information. The boats come
in at 6:30 a. m. and 6 or 7 p. m.
There are three lines running to
Norfolk. The personal of the cases
range over a wide field—young girls
or children alone, foreigners hardly
speaking any English, those who
were ill, colored and white, some
of whom were for the first time
on the water.

WARNING.
The Travellers' Aid Society would
warn any girl going from home
either seeking employment or for
other reasons:
1st. Not to start without knowing
where she is to stay at night and
having money enough to defray ex-
penses.
2nd. Not to answer advertise-
ments for workers at Jamestown,
without first writing to the Trav-
ellers' Aid Society who will tell her
if it is an honest offer of employment.
The Travellers' Aid agents both
in Norfolk and Baltimore will meet
those who write to them in time.
Look out for the Travellers' Aid
badge and mention the color of your
hat or some other distinctive mark
of your dress.
