The land belonging to our town site contains nearly 1300 acres, the portion which is not built upon, being covered with timber. It abounds in building material of every description, and the health is unsurpassed anywhere.

The first claim was made here, we believe, by the summer of 1856, but as the Iowa Trust Lands were not opened for settlement until the fall of 1857, it was not until the summer of 1857 that the project of starting a town here was abandoned for the time being.
