Ever since the wise men brought their gifts of gold, frankincense and myrrh to lay at the feet of the Christ child, love has chosen the Christmas season as the appropriate time to give gifts of affection and friendship to others. My joy in this new service will be greater if you join me in its spirit that our Christmas celebration may be kept simple, filled with good will, winged with sacrifice, and devoted to peace."

Dr. C. G. Parlier Dead.

Wilkes Patriot, 17th.
Dr. C. J. Parlier, who was widely and most pleasantly known in this county, died at the Charlotte Sanatorium, at Charlotte, late yesterday evening, following an extended illness. He suffered from a complaint known as a hardening of the blood vessels. More than a year ago he abandoned his profession as a physician, to seek relief in rest, and so far improved that he resumed it again, at his home at Blowing Rock, early last summer. Dr. Parlier was born and reared at Moravian Falls, at which place he lived and practiced medicine, until about fifteen years ago, when he went to Blowing Rock. He was a successful practitioner and business man and leaves considerable property. His aged mother, Mrs. T. P. Parlier, still resides at the family homestead. There are two brothers and two sisters. J. R. Parlier, of Moravian Falls, and C. E. Parlier of this place, and Mesdames K. L. Scroggs and Lillie Sloop, both of Moravian Falls. Dr. Parlier's age was about fifty years, and he was never married. The body will arrive today, accompanied by Mr. and Mrs. Scroggs, and will be buried at Moravian Falls tomorrow afternoon.

Moving Ahead.

Durham Sun.
Business continues to improve. There is no more cheerful theme and all of us may be pardoned if we seem unduly joyous over the tangible evidence that commerce of all kinds is getting back to normal.

No less authority than Dun's Review says that conditions throughout the country were materially better last week than at any time since the beginning of the European war. In discussing the feature of last week's business the Review says:

That there is improvement in trade is made clear in the reports from all parts of the country. Holiday buying is developing very well, and the colder weather has stimulated retail distribution and also helped some wholesale departments. Iron and steel consumption is increasing and concessions in prices are less frequent. Larger sales of wire and tin plate are reported and the railroads are contracting for limited quantities of rails and other supplies. In the dry goods market here is visible an improved demand, buying of spring merchandise becoming more noticeable. The woolen division is kept reasonably active by the European requirements. It is announced this week that the London Embargo on wool is to be raised on guarantees that no shipment to hostile countries will be made. The shoe and leather industry reports a broader domestic demand in addition to the large foreign orders. The prevailing optimism is strengthened by easier money and the notable improvement in the financial position; also by the fact that the corner has been turned and the trend is now toward better conditions. The most important development of the week is the resumption of trading in stocks, under certain restrictions, on the New York Exchange and this marks a practically complete return to normal conditions so far as the machinery of the financial market is concerned. Business can now be carried on in the regular way without the necessity of extraordinary expedients, and with the added security and advantage of the vastly increased credit facilities which the Federal Reserve Bank system affords.
