Hurley of Hartford. Everett Hewitt, alias of Lebanon, was arrested by State Policeman Hurley Thursday forenoon for turning the trick. He was taken before Justice of the Peace Burgess of Lebanon and found guilty and was bound over to the May term of the superior court of the county under \$1,000 bonds. It developed at the justice's trial that Hewitt stole the cow and took her to his home in the city of Lebanon and then sold three quarters and kept the other quarter for his own use. The fact that the crime is a felony is the only reason that it is not outlawed. It is punishable by a five-year sentence in state's prison, according to section 1295 of the general statutes.
