Discretionary Powers of Judge. Several possibilities confront Thaw. The court may grant his plea and may make him absolutely free. It may decide that he has not established his sanity and refuse to interfere, in which case the state authorities will probably send him straight back to Matteawan. But Justice Mills has further discretionary powers. He may feel that the young man's mental condition is still in doubt and for that reason delay a final order, meanwhile paroling Thaw in custody of some officer, or possibly his own recognized master, in the care of his family. Or he may declare Thaw insane, but, moved by his brother's complete assurance of the surroundings at Matteawan, send him to another state hospital not peopled by criminals.
