NEW SUITS BROUGHT IN SUPERIOR COURT.

Additional Business Returned for March Session.

Mr. and Mrs. Calvin Wilcox of Lisbon sue Albert Lebarre of Plainfield for \$400 damages to recover the sum of \$300 lent him before July 25.

Angelo Covello of Norwich, adm. of the estate of Pasquale Paldino of Norwich, sued the Connecticut company for \$5,000 damages for the death of Paldino, who on Nov. 10, 1909, was killed by a car of the company near St. Regis avenue, in Norwich.

It is claimed that the company failed to keep a proper lookout on the car for the plaintiff's interstate walking in said highway, and crossing the track and negligently failed to sound the whistle or gong on the car.

The New York, New Haven and Hartford Railroad company on Wednesday brought three suits against Charles H. Richmond, Elmer E. Richmond, Mary A. Richmond and Nellie T. Rose, all residing in Pawcatuck, in the town of Stoughton.

The suits were brought for the recovery of land now in the possession of the defendants, but which the plaintiff alleges is owned by it. The plaintiff claims \$1,500 damages in each suit and possession of the land.

In the first suit, in which Charles H. Richmond, Elmer E. Richmond and Mary A. Richmond are the defendants, the New Haven road seeks to recover a lot of land on the northern side of West Broad street from which it alleges that it has been dispossessed, depriving it of rents and profits.

The same persons are made the defendants in the second suit, in which the plaintiff seeks possession of a lot of land adjoining the piece in question in the first suit.

Nellie T. Richmond is the defendant in the third suit, in which the New Haven road claims possession of a piece of land adjoining the other two pieces. All three pieces were formerly owned by the New Haven road, from which it alleges that it has been dispossessed by the defendants, who have erected dwelling houses on the property.

MILCH GOAT KEEPERS.

Second Annual Meeting Held at West Hartford.

The second annual meeting of the Connecticut Milch Goat Keepers' association was held Tuesday evening at West Hartford.

The following officers were elected: President, George W. Smith, Melrose; vice president, Milo N. Wooding, Hamden; secretary, Alfred Dixon, treasurer, James A. Smith, Hartford. The annual dues were increased from 50 cents to \$1. Rural Life, a monthly paper, was chosen as the official organ, and will be sent free to all the members, out of the membership fee. Though local in name, the society has members in seventeen states and in Canada, and it soon expects to incorporate under Connecticut law. The secretary of the year showed the loss of but one member, Hon. John Gower, judge of the county court at Windsor.

The program of the evening was seeking to popularize the milch goat, and has physicians, ministers, farmers, ladies' mechanics and others on its membership roll.

DR. NASH AT TRINITY CHURCH

Preached Scholarly Sermon on Repentance at Union Lenten Service—Church Filled to Hear Prominent Preacher.

For the second of the united Lenten services in the middle of the week, Trinity Episcopal church had an aggregation on Wednesday evening that filled the body of the church, attracted to hear Rev. Henry S. Nash, D.D., who is professor of the New Testament in the Episcopal theological school at Cambridge, Mass. Archdeacon J. Sidre, Brown of Trinity church, Rev. Neilson, Ede Murray of Christ church, and Rev. F. Johns Bohanan of St. Andrew's church conducted evening prayer, which was followed by the reading of a scholarly sermon by Dr. Nash.

For a text the preacher quoted the verse, "Jesus began to teach and to say: 'Repent for the kingdom of heaven is at hand,'" and went on to repeat that once in a while the vision of a divine reality might touch the soul. But this was at the cost of setting the nation, and Jesus would have nothing to do with their way of talking about the kingdom of God. There was a second favorite way of talking about the kingdom of God as illustrated by the Pharisees who left in writing the Apocalypse, whose chief purpose was to turn the eyes of the sinners and heathen theological domination. Jesus would have nothing to do with that way. There was a third way which was that of the Galilean peasants, who were ready to stake their life upon a fight with the Roman government, upon their belief.

But Jesus brought the kingdom of God down out of the heavens to the people. He was too great a teacher to give any distant, unapproachable ideas, and his chief work was to realize the kingdom of God in terms so simple that the people could not think with him without realizing the kingdom of God.

There were two chief texts he used, the first being the Old Testament quotation, and the only one from the Old Testament that he used twice, "I desire mercy, not sacrifice." To desire mercy meant not merely compassion, but that most difficult of all human prerogatives, the ability to overcome our own prejudices and to find on the other side of the wall which they erect people as worthy in God's sight as ourselves. Jesus calls upon us to be ashamed of the overvaluation of the little things that get between us and our fellows.

And the second great text of Jesus was the parable of the Good Samaritan. This thought was amplified by the preacher in an interesting way with a comparison of the two different individuals he finds in himself as revealed by the lesson of the automobile. For the greater part of the year, he said, he was a footman, and the situation of that he avowed from his neighbors' automobiles was inconceivable. At that time he was urgent and an zealot for the enforcement of speed regulations, and he adhered to the law. But on the few occasions in the year when his friends would invite him to a ride in the automobile, he found he was a different creature when he is a footman. Having been named as special agent to secure a census of the almshouse, John J. Corkery has completed his work as far as possible, but he will keep track of the changes there on slips furnished by the government until they notify him to cease.

On the 1st of January there were 99 inmates—69 men and 27 women. As the census is constantly changing, as spring approaches the number will decrease. At the present time there are but 82 there, four having died since January 1st, six having been discharged, while four have been admitted.

TRAGEDY IN A THEATER.
Two Men Shot at the Stage Entrance—Show Not Interrupted.

Indianapolis, Feb. 15.—Fatally wounded by two bullets fired by Adolph Casassa, a violinist, Louis R. Ostendorf, manager of the Empire theater orchestra, tonight overpowered his assailant, wrested the revolver from him, and fired three bullets through Casassa's head, killing him instantly at the stage entrance of the Empire theater. Ostendorf died in a hospital later. The shooting occurred just before the curtain rose for the night performance and the audience was kept in ignorance of the tragedy until the show was over.
