Flood of Bills, Petitions and Resolutions Filed and Referred.

Speaker Scott called the house to order at 11.23. Prayer by the chaplain. There was immediate filing of many bills, resolutions and petitions by members from every section of the state and relative to many and varied matters. Among them were the following:

Tobacco Demonstration Farm.

Duties of Sealers of Weights and Measures.

Mr. Deering of Norwich—A bill relative to the duties of sealers of weights and measures. Judiciary.

Section 1 of the bill provides for the filling of a scale at each service station for sealers, persons whose articles are inspected to pay said fees.
