JUDGE O'GORMAN SUCCEEDS DEPEW

Elected United States Senator from New York on the 64th Ballot

WILD REJOICING FOLLOWS BALLOT

Democratic Insurgents Capitulated and Made Election Possible—O'Gorman Resigns Place on Supreme Bench, With a Salary of \$17,500, to Become Eligible to Election—Both Dix and Murphy Satisfied.

Albany, N. Y., March 31.—Supreme Court Justice James Aloysius O'Gorman, democrat, of New York city, was elected United States senator tonight by the legislature after the most protracted struggle over this position that is recorded in the annals of the Empire state.

Legislators Hugged Each Other. Members were hugging one another in their joy at this ending of the wearisome struggle and they congratulated each other.

O'Gorman a Tammany Favorite. James A. O'Gorman has long been one of the most prominent members of Tammany hall. He has been one of its foremost orators for thirty years, having retained his reputation as a public speaker in the interests of the political organization when, at the age of twenty-one, his eloquence was combined with doubtful political ability.

Result Granted With Applause. Wild applause marked the end of the long contest and the legislature, driven from the state capitol by Wednesday's fire, quickly adopted a resolution adjourning until April 17.

Murphy Also Pleaded. Charles P. Murphy, leader of Tammany hall, who has been striving to bring about the election of Mr. Sheehan, expressed himself as highly pleased at the outcome.

Meyer Receives Many Protests

DESTRUCTION OF THE TEXAS AROUSES SOME CRITICISM. SENATOR MAKES INQUIRY

Wants to Know, if It is Not a Waste of Money—Naval Secretary Explains Battleship Had Outlived Usefulness.

Washington, March 31.—Secretary of the Navy Meyer replied today to a communication which he received from Senator Perkins of California, chairman of the senate naval affairs committee in which the latter said that he had been receiving protests because the San Marcos, formerly the battleship Texas, was being used for experimental purposes.

Texas Was a "Death Trap." "Secretary Meyer told Senator Perkins in his reply that the San Marcos would have been nothing better than a 'death trap' if it had not been in actual battle. The vessel, he said, was obsolete in design and the experiments on its outfit were of far greater value to the navy than any other way.

Experiments Were Useful. The experiments, the secretary believed, have been of great value in actual firing practice secured out in the lessons, which they taught to the naval constructors and which will be water in working up the designs for new battleships.

Vessel Worth Only \$35,000. Before the tests were made the vessel was worth only about \$35,000 as junk. The secretary says it is in the hands of the navy, and he hopes to obtain about as much as this for the vessel, even in his present battered condition.

Old Foe Fighting Purposes. The vessel, he continues, was early out of date, having been constructed about 22 years ago, and he cites naval authorities to show that a vessel which has reached that age is practically useless for fighting purposes.

Claims No Cruelty to Cats. Humanitarian protests having been received by Secretary Meyer from various societies for the prevention of cruelty to animals because a number of live chickens and cats were aboard the Texas during the target practice, the secretary has replied that no cruelty was shown the animals concerned.

To Discover Effects of Gases. "These animals," he says, "were put on the ship in order to obtain information as to the effects of the gases of explosive shells. They were removed after the firing.

May Save Human Lives. "It is only by such experiments on dumb animals in time of peace that facts can be learned that may lead to the amelioration of brutality and needless suffering and destruction of human life in time of war. To obtain information as to effects of fragments of shells, manna made of saw-dust were employed."

Chickens and Cats Are Mascots. The chickens and cats which were on the old battleship were carried off after the firing by the crew of the various vessels of the fleet. They are being honored because they went through the thick of a big battle and won glory. The mascot rivalry among the various ships, each being anxious to obtain one of these valuable mascots.

GAYNOR TO PREVENT "POLICE MILLIONAIRES." Says Great Body of Police Today is Absolutely Honest.

New York, March 31.—No more police officials in New York will retire as millionaires, Mayor Gaynor has announced. He has ordered an investigation to address the City club, the mayor wrote one of his characteristic epistolary letters in which he and the police department from the current charges of inefficiency in policing the metropolis.
