Final dealings reflected a mixture of short selling and further profit taking. Dealings were light, with alternate fractional gains and losses, but net result favored the bull account in the main, even though gains in some of the leaders were completely wiped out.

Local banks are threatened with another loss of cash this week, albeit the drain promises to be small.

Bonds were firmer, with especially large dealings in the Erie issues. Total sales, par value, amounted to \$3,611,000.

DU PONT'S DELAWARE ROAD SOLVING SERIOUS PROBLEM. 105 Miles Built Free of Expense to the State.

Although at the present time there are between 15,000 and 20,000 miles of improved roads in the United States, either under construction or proposed, no section of road is receiving the attention which it is being watched as closely by the road makers and by good roads advocates, as is the 105-mile road which Gen. T. Coleman duPont is constructing at his own expense through the state of Delaware.

To quote the general's own words: "My object in building the road is not only to provide a good highway where it is badly needed, but also to work out in a practical way a problem that will, if successful, revolutionize the building of roads in the United States."

Suppose, for instance, that the Delaware road was being constructed by this method, instead of being given by General duPont. On the American road some 25 acres of land have been condemned for every mile of road.

General duPont has conceived several other features, which he intends to put through, and which will be of great value to the state. One of them is the foundation of several agricultural experimental stations, in charge of trained men, which will be maintained by the revenue of the road.

In the actual construction of the road many experiments are being tried which will be exceedingly useful for reference purposes and for the guidance of future road makers.


