GOVERNMENT BUILDING AT MYSTIC IN BILL

Included in So-Called "Pork Barrel" Measure at Washington.

(Special to The Bulletin.)

Washington, Feb. 17.—Representative Burnett of Alabama, chairman of the house committee on public buildings and grounds, late Saturday afternoon reported his so-called "pork barrel" bill carrying \$2,843,000 so scientifically distributed that nearly every member of the house republican and democrat alike, gets a slice.

The bill authorizes the secretary of the building and ground department for the erection of buildings upon sites already owned by the government at Rockville at a cost of \$15,000 and at Greenwich at a cost of \$20,000, and he is directed to acquire by purchase or condemnation sites and erect buildings thereon at Mystic and Branford at a cost of \$55,000 each, including sites.

Representative Kelly secured the insertion of a section providing for the increase of the limit of cost of the public building at New Haven from \$100,000, or so much thereof as may be realized by the sale of the old post-office and custom house building on the site thereof, and the secretary of the treasury is authorized to sell the old building and the proceeds therefrom to be used in the construction of the new federal building, with a provision that possession shall not be delivered until the new building is ready for occupancy.

It is expected that this bill will meet with a favorable reception by the leaders on the floor of the house.

Will Manufacture Suction Roll for Paper Making Machines.

In the list of new corporations incorporated at the state capital is that of the Binns Revolving Paper Company of Norwich, incorporated Feb. 8, 1913, to make machinery, etc. Capital stock \$100,000.

The incorporators are Binns R. Platt and O. E. Wolf, all of Norwich.

Mr. Binns, who is a South Windham man, is the inventor of a suction roll which extracts the water from paper pulp through a vacuum process which he declares has been cleaned up after all present methods, so that the machine will be used for office paper for all paper making plants.

Just at present the company is only in the preliminary stages of the selection of site, election of officers and other details of organization are all a matter of future development.
