SULZER'S FAIR IN HANDS OF JUDGES

Arguments Concluded Yesterday and Court Adjourns Until Monday Afternoon

GOVERNOR SAVAGELY ATTACKED BY LAWYERS

Accused by Judge Parker of Attempting to Hide Behind His Wife's Skirts—Attorney Brackett Suggests That Senator Stillwell, Now in Sing Sing, May Have Learned Crime From Sulzer—Defense Pleads No Criminal Intent

Albany, N. Y., Oct. 10.—Governor William Sulzer's fate tonight rests with the judges. The final arguments of counsel for and against him were delivered today before the high court of impeachment. Immediately thereafter the court adjourned until next Monday afternoon at 12 o'clock.

Upon re-convening the court will decide upon its plan of balloting, whether it shall be by ballot Monday night, or by viva voce on Monday afternoon. Popular Demand for Open Session. A decision of his fitness to continue in office will be reached Monday night. It is generally believed, but there are doubts as to whether a great deal of discussion among the judges will precede the final vote.

"Hiding Behind Wife's Skirts." As a compromise to extend the usual Friday session an hour and a half and permit Attorney Brackett to finish his case, the court adjourned until Monday afternoon at 12 o'clock.
