CITY BUSINESS
Transacted by Board of Aldermen in March Meeting.

The regular monthly meeting of the board of aldermen was held in the town building Monday night with a full board in attendance.
After the acceptance of the clerk's minutes of the previous meeting, several citizens who were in attendance were heard.

Police Department Report.
Chief E. H. Richmond's report for the police department was read and accepted. It showed 26 arrests, 4 sent to jail, 1 committed to the industrial school for girls, 12 released by the chief, 2 paid fines and costs, judgment suspended in 2 cases, otherwise disposed of 4, tramps lodged, 22 electric lights out, 59 houses, 9 doors found open and secured, and 105 complaints received.

Snows Made \$400 of Expense.
The report of Superintendent of Streets E. O. Sumner showed the expenses of the department from Feb. 7 to March 7 to have been \$37.55, over \$400 of which was for opening gutters and cleaning crosswalks after the recent snows. The report was accepted.

Sidewalk Applications.
Applications for sidewalk construction were received from E. D. and W. P. Jordan, Main to Windham streets; George S. Elliott, north side of Main street; and Luther north side of Main street; state board of education.

Elks Will Illuminate.
