

# Norwich-Westerly Trolley Privileges

### Town Council Votes to Grant Permission for Turnout in Railroad Square and Siding Down Canal Street—Charter for Thames River Corporation, Headed by Arthur H. Gulliver—Frederick W. Wood Found Drowned.

The desire of the town of Westerly, as officially expressed in town council and financial town meeting, that the law be so changed as to permit the holding of town meetings in the evening instead of in the morning, has been defeated by the action of the lower branch of the general assembly. The proposition was opposed in the house by Representative Albert H. Langworthy, who is also president of the Westerly town council and a republican. The matter was referred to the judiciary committee and it was planned to have it killed in that committee by the pigeon-holing process. Representative Joseph T. Murphy, also a republican, succeeded in having the matter recalled from the further consideration of the committee and it went to the calendar.

When the proposed amendment was taken from the calendar for action Mr. Langworthy spoke in opposition to its adoption and moved for indefinite postponement, but the motion prevailed by a vote of 63 to 28. This indicates that Mr. Langworthy has some pull in the lower house of the general assembly of the state of Rhode Island.

Dr. Henry E. Utter, son of the late Congressman and Governor George H. Utter, is booked for appointment of medical inspector of the schools of North Providence and will be formally elected at a meeting of the school board Tuesday evening as three of the five members have been selected to accept appointment. Dr. Utter says he has considered the matter thoroughly and will accept the state authorization of the appointment of medical inspectors and most of the Rhode Island towns have them, but no such office has been created in North Providence. At the annual financial town meeting last November last, and mysteriously disappeared, causing much anxiety to his wife and twelve year old daughter, was found drowned in the Paycatuck river, Sunday afternoon. No cause can be assigned for his disappearance and it is not known whether death was due to accident or intent. He was 40 years of age and of an industrious nature.

The Westerly town council met in special session Saturday evening. Clarence Maxson was appointed a committee to make agreement with the courthouse commission relative to the care and heating of the courthouse which was built in conjunction with the town hall and also as to the rental to be paid to the state for the use of the basement of the courthouse, except on the main line. Councilman Albert H. Langworthy said it was about time to take action in regard to the purchase of land for filling the public highways and that about 28,000 gallons would be required. The cost would be six cents a gallon or half a cent less than paid last year. No action was taken.


More Witnesses Summoned Before Court of Inquiry—Water Stops Bridge Repairs.
