SALE OF WOOD BUILDING.

Will Probably Be Authorized Today by Superior Court Order.

It is expected that an order will be issued in the superior court for Woodham county today (Friday) authorizing the receiver of the A. F. Wood company, Charles A. Tillingshast, to complete, as agreed upon, sale of the Wood building to Charles H. Pellett. This is one of the most important real estate transactions in Danielson in a number of years.

Mr. Pellett said Thursday that his plans relative to the building have not been completed. He expects, however, to occupy a part of the big structure for his own business purposes, probably also retaining his present quarters on Mechanic street for repair work, etc.

In all probability the present tenants of the building will remain. This is true in the case of A. F. Wood, who leases quarters at the front and on the upper floors of the building, the Adams Express company and probably in the case of H. H. Starkweather.

Mr. Pellett plans for a show room for the line in which he is interested in and will have his office at the Mechanic street corner.

A court order to authorize the sale of the building as agreed upon between Receiver Tillingshast and Mr. Pellett is necessary because of the fact that the A. F. Wood company, which owns the structure, is now in the hands of the receiver.

Woodsstock Scandal. Edward Weaver Bound Over Under \$800 Bonds on Shocking Charge—His Daughter Named in the Complaint.

Edward Weaver, about 55, well known in this city, but all of his life a resident in the town of Woodsstock, was arrested Thursday on a charge of incest. Weaver was taken into custody by Deputy Sheriff Leonard H. Healey, who had been on the watch for him since April 16, when the complaint charging him with incest, Weaver's daughter, Faith, being named in the complaint, was issued.

Previous to that date a complaint charging Weaver with assault had been issued. Woodsstock people have known for some time of trouble in the Weaver household, but have been very reticent in giving information about it; some of them have refused to talk about the case.

They have known that Miss Faith, who is said to be about 20 years of age, has been a patient at the Dayville hospital, but they would not even admit this to be true when questioned relative to the case.

When arraigned before Justice Charles M. Perrin in Woodsstock for

a hearing Thursday afternoon Weaver pleaded not guilty. Attorney Eric H. Johnson of this city prosecuted for the state. Attorney Charles L. Torrey represented Mr. Weaver. On the witness stand Miss Weaver, who has been discharged from the hospital, testified that her father had not had carnal knowledge of her. Mrs. Elmer Cortis testified under oath that Miss Weaver had made confessions to her relative to the father's relations with the girl.

Mr. Weaver is a graduate of Woodsstock academy. He is well known in the town and at one time was a man of means. As a student he showed an unusual degree of intellectuality and was one of the ablest debaters in the school.
