WHAT IS INTERESTING WESTERLY

State Christian Endeavor Union Convention Today—Conductor Bartlett Has to Sand Back Talk From Boozey Passenger—Town Sued by Providence Woman.

The act amending the charter of the New York, New Haven and Hartford railroad which was given a hearing in the Connecticut state capitol last week, was practically a general law and was intended to cover special purposes relating to mortgages in two particulars. At the suggestion of Senator Whiton, chairman of the railroad committee, that an amendment covering the special purpose be substituted for the general law, was favorably considered and a new amendment will be substituted.

The same matter was before the committee on incorporations in the general assembly of Rhode Island and a favorable report was made recommending passage of a similar law. A resolution, on motion of Representative Albert H. Langworthy, of Westerly, house chairman of the committee, and the committee on incorporations in the Connecticut, as suggested by Senator Whiton of New London. This change is agreeable to the railroad company and more acceptable to the general assemblies of both states.

The substitute bill reads as follows: "The New York, New Haven and Hartford Railroad company be authorized to sell, pledge or otherwise dispose of and to assign and transfer for the purpose of the whole or any part of the capital stock of the Boston and Providence railroad corporation, which is the old Colony Railroad company, which it holds and has heretofore acquired under charter amended, which went into effect June, 1899 and March, 1893."

Among the passengers on the train, eastbound, due to arrive in Westerly at 10:25 Saturday morning, was a well dressed and attractive looking man, who had the appearance of a well-to-do New York broker or business man. He failed to purchase a ticket at New London, where he boarded the train, and told Conductor Bartlett that his destination was Providence, paid his cash fare and was given a rebate check for that destination. Before the train reached Westerly, the passenger informed Conductor Bartlett that he had been short changed and the conductor pocketed the money. When the train reached Westerly, the passenger verified and during his talk it developed that he was bound to Mystic and not Providence. The conductor remarked to the passenger that he must have changed his mind and immediately handed back the difference in fare. Then the conductor asked for the rebate check but told the passenger to substitute terms that he gave no rebate check and short changed the passenger. More indignantly, Conductor Bartlett a liar and a thief. This occurred in the smoker, and rather than have words with the passenger, the conductor walked into the baggage compartment. The passenger followed him, opened the door and told the conductor he would make a complaint to the railroad.

When the conductor asked for the rebate check he without it he was "shorted" the passenger. The passenger denied having received a rebate check although the conductor insisted on three other passengers who heard the man say that his destination was Providence and saw the conductor give him the rebate check. On the depot platform in Mystic the conductor was subjected to more abuse, but he retained his self-control and thereby exhibited his gentlemanly qualities. The dining passenger appeared to be slightly under the influence of strong drink.

In the superior court for Washington county Judge John W. Sweeney, at Friday's session at Kingston, heard appeal from probate, Silas B. Briggs, et al. appellants, against Evelyn A. Briggs, et al. respondents. Attorney for defendant announced that the case had been adjusted and decree was entered.

The divorce case of Isabella Cook against George Cook, the court granted a separate maintenance with an allowance of three dollars a week and custody of two minor children, one the petitioner. Margaret Westfield was divorced from Carl Leo Westfield, on grounds of neglect to provide, and the petitioner was allowed to resume her former name.

The war department order organizing the militia of the several states into a national defense force, specifies that in the event of hostilities the Rhode Island mobilizing place would be at Quonset Point. The forces assigned to the coast defense are divided into local divisions are seventeen companies of coast artillery, consisting of 1911 men. Provision is made also for three troops of cavalry of 300 men, one battery of field artillery, of 171 men, and one ambulance company of 79 men.

The plan contemplates that Rhode Island should furnish a quota of 2,360 men on the basis of a field army of 400,000. The total Rhode Island militia men now available is 2,461.

Suit has been brought against James M. Pendleton, as town treasurer, representing the town of Westerly, by Mrs. Mary G. McKnight of Pawcatuck. The complaint charges that on the evening of September 18, 1914, by reason of falling on the concrete sidewalk at the corner of Broad and Main streets, near the store of the Howard Clarke, Mrs. McKnight claims that the heel of her shoe caught in a depression in the sidewalk and she fell receiving serious injuries. She declares that she fell on her hands and knees, rupturing the ligaments on both knees, straining the muscles of the body and that she sustained a nervous shock, suffering internal injuries. Mrs. McKnight seeks damages of \$4,000.

The November meeting of the Westerly town council through her counsel, Albert E. Crafts, Mrs. McKnight served notice of the injuries received and of the claim for damages, but no action towards a settlement was taken by the council, and the suit is the result. Plaster casts have been taken of the alleged defect in the sidewalk where the accident occurred, under the direction of Attorney Crafts and Town Solicitor Harry E. Agard. Mr. McKnight claims the sum of \$1,000 as a like amount for the loss of his wife's services.

The superior court for Washington county will convene in Westerly on Tuesday. Judge John W. Sweeney will preside as judge for the first time in his home town. NEXT AUTO REGISTER WILL COST STATE NOTHING

Two Hartford Men Have Taken the Contract—Will Make It More Useful.

Under the contract made for the publication of the next automobile register of the state, which has been taken by Arthur Fifoot, secretary of the Automobile club of Hartford, and Albert M. Simons, deputy sheriff, a booklet of motor vehicles, more than heretofore is expected to be issued. As nearly as can be told from the records of the automobile department at the state capitol, \$2,000 is a moderate estimate of what it cost the state to print, bind and distribute the two 1914 editions of the list of registered motor vehicles.

Under the new plan this sum will be saved to the state. Mr. Fifoot and Mr. Simons agree to publish the register free of cost to the state, to furnish the secretary of the state, free of expense, 1,000 copies of each edition, as many copies as may be needed by him for official purposes, also to deliver to each owner of an automobile or motorcycle registered in the state one copy of each edition without cost to the state by the owners.

The new contractors are permitted to publish supplemental lists to the regular editions containing names and data concerning owners registered since the publication of the preceding edition. They are also permitted to solicit advertising for the register and are allowed access to the records of the automobile department of the state for the purpose of compiling the register. Mr. Fifoot and Mr. Simons are required to give bond for \$1,000 for the faithful performance of their agreements and the contract will be in force until the next year when it will be renewed.

minable upon fifteen days' notice by the secretary of the state for failure to perform any of the agreements of the contract.

Although the contract demands only that the new register shall contain the names and registered numbers of owners of automobiles and motorcycles in Connecticut and "as much information as is necessary to be published in the automobile register of the state of Connecticut." It is apparently the intention of Mr. Fifoot and Mr. Simons to give information and make certain changes which will make the book of infinitely greater use to motorists. Mr. Simons said recently, "we will issue two editions, one about June 1 and September 1. In addition, we intend to publish monthly supplements. We will give a great deal of information not formerly included in the register. Whereas last year's registry number, the owner's name and the town in which he lived, our book will give the owner's street address, make of his car and the model and also the taxable horsepower of his car. Our book will also give the automobile number of the state, possibly road marks and other information of use to Connecticut motorists. The supplements will contain the most ordinary information in the cities throughout the state.

"Our chief idea is to give Connecticut motorists as much helpful information as possible. The book will be more on the lines of a reference book, rather than a mere registry list."

CONNECTICUT SHIP FOR BELGIAN RELIEF
