WILL TRY TO ORGANIZE LEAGUE FRIDAY Manager Holland of Sachems Will Meet With Other Managers for the First Time at the Bulletin Office—Several Managers Want to Limit Players to Only Local Men.

The first meeting of the managers of ball clubs in eastern Connecticut will be held at the Bulletin office Friday evening at 7:30 o'clock. Already several managers have signified their intention of entering the league, if arrangements are suitable, but it appears to be at present quite a situation to overcome and that is the reason the players only have a chance to take in more receipts than others playing only Saturday games at home.

A league of this sort will be a great lift off the shoulders of the managers, as each week they are bothered with the task of slating a team that will give a good exhibition and one that will give the fans their money's worth, while on the other hand a league which unquestionably will create a wide-spread interest will know what kind of a team the visiting aggregation will be.

Another obstacle to overcome will be the signing of players. Several managers are desirous of limiting the players to only local men, which seems to prevail mostly. Others want to obtain the players only from New London and Windham counties. Moosup has a team, it is reported, with players in the lineup from the state of Rhode Island.

Manager Holland of the Sachems had a short conference with Mickey Finn of New London, Sunday evening, and the two will be in conference Friday evening and is very enthusiastic over the new organization.

ANNUAL OPEN GOLF CHAMPIONSHIP OF COUNTRY

Players Gather at Short Hills, N. J., for the Big Event.

Short Hills, N. J., June 14.—Most of the prominent amateur and nearly all of the professional golfers who are to take part in the twenty-first annual open championship of the United States Golf association were at the Balmoral club's links today and many of them played over the course.

The weather was exceedingly warm and some of the visitors were on the verge of prostration when they reached the links, but after a short rest and a cut of the links, par for which is 74 and the professional record 71.

The best score of the day was a 71 by J. H. Nicholas, a former professional who won the Shawnee, Pa., tournament last week. Nicholas made this score in a match with Alec Smith, a former professional, after the second round, against Chick Evans of Chicago, the western amateur champion and Jim Donaldson, the Glen View, Ill., champion, who were the opponents in the first round.

CREWS HAVE GOOD WEATHER ON POUGHKEEPSIE

Poughkeepsie, N. Y., June 14.—A strong ebb tide with slight north wind made such perfect conditions on the Poughkeepsie course today that the crews of the Cornell, Columbia, Pennsylvania and Syracuse regatta, training for the intercollegiate regatta, sent their crews down the course at a speedy clip, the varsity crews of Cornell and Columbia being sent away for time runs.

Late today all the crews here were paddling about the starting point waiting for a chance to go down the course. The three Cornell shells got away first, the freshmen quitting at the two mile mark, and the junior and senior crews fighting it out to the finish, with the advantage much in favor of the seniors.

Columbia went through a similar programme, ending with a hard row for the varsity eight.

The Syracuse and Pennsylvania crews went about a mile above the starting point and then took a hard pull of three miles down stream. The Pennsylvania varsity crew was again beaten by the juniors.

YALE CREWS PRACTICE STARTS.
