COMPENSATION AWARD IN SUM OF \$20,711

In Claim of Amos Grandall Against Allen Avery, Late of Mystic. A finding and award in the case of Amos Grandall of Mystic, claimant, against Allen Avery, late of Mystic, has been made by Compensation Commissioner Dr. James J. Donohue, after the hearing that was held before him on July 23.

The following facts were found: That both parties named were within the scope of the workman's compensation act, etc.; that Avery was injured while in the employ of the respondent at Mystic, claimant, received an injury caused by a steering upon which he was working, giving way, which caused claimant to fall to the ground, spraining his left ankle. Said injury arose out of and in the course of his employment. It was agreed that the average weekly wage of the claimant was ten dollars. Claim for compensation was made by the claimant but the respondent had not effected an agreement in regard to change of measurements, and that claimant was not disabled a sufficient length of time to be entitled to same. The respondent stated that on March 1, 1915, the claimant returned to the employer's house and reported for work, but owing to the fact that the work had been completed, he did not return to work for Mr. Avery but did odd jobs for various parties, and it was found that the date of his return to work was March 29, 1915. It was further found by the claimant's testimony that he had received no medical attention, having advised himself of none of the services mentioned under Section 7 of the act, which lack of medical attention has unnecessarily prolonged the disability. Er. W. H. Gray of Mystic testified that he had made an examination of the injured ankle on July 21, 1915, and he found no restriction of motion, no change of measurements, and that he considered a man, with proper treatment following a sprain, ought to get around comfortably on his foot in a month. It was further ascertained that Mr. Allen Avery (since deceased) had paid claimant two different sums of money: one payment being \$5 and the other \$5, since the injury. Whereupon, it is hereby awarded, adjudged and decreed by Compensation Commissioner Donohue, that the respondent shall pay to the claimant forthwith compensation at the rate of five dollars weekly for four weeks, beginning on March 29, 1915, amounting to \$20.71, from which amount the \$11 already paid shall be deducted, leaving the amount to be paid to claimant \$9.71.

ASSESSORS MUST MAIL LISTS TO NON-RESIDENTS. New Law Puts Additional Work Upon the Board. One of the new laws passed by the last legislature will oblige the Norwich assessors to mail to non-resident property owners about 400 blank forms for the filing of tax lists. There are about 352 non-resident property owners, but some require two or more lists. The new state law on this subject is as follows: The assessors of real estate of tangible personal property located in any town more than seven months during the year, who are non-residents of such town, shall file lists of such real estate and personal property with the assessors of the town in which the same is located under the same provisions as apply to residents. The assessors shall mail to each non-resident or his attorney or agent having the custody of his taxable property, at least 15 days before the expiration of the time for filing lists, blank forms for filing lists of such estate or property.

COMPENSATION AWARD IN SUM OF \$20,711

In Claim of Amos Grandall Against Allen Avery, Late of Mystic. A finding and award in the case of Amos Grandall of Mystic, claimant, against Allen Avery, late of Mystic, has been made by Compensation Commissioner Dr. James J. Donohue, after the hearing that was held before him on July 23.

The following facts were found: That both parties named were within the scope of the workman's compensation act, etc.; that Avery was injured while in the employ of the respondent at Mystic, claimant, received an injury caused by a steering upon which he was working, giving way, which caused claimant to fall to the ground, spraining his left ankle. Said injury arose out of and in the course of his employment. It was agreed that the average weekly wage of the claimant was ten dollars. Claim for compensation was made by the claimant but the respondent had not effected an agreement in regard to change of measurements, and that claimant was not disabled a sufficient length of time to be entitled to same. The respondent stated that on March 1, 1915, the claimant returned to the employer's house and reported for work, but owing to the fact that the work had been completed, he did not return to work for Mr. Avery but did odd jobs for various parties, and it was found that the date of his return to work was March 29, 1915. It was further found by the claimant's testimony that he had received no medical attention, having advised himself of none of the services mentioned under Section 7 of the act, which lack of medical attention has unnecessarily prolonged the disability. Er. W. H. Gray of Mystic testified that he had made an examination of the injured ankle on July 21, 1915, and he found no restriction of motion, no change of measurements, and that he considered a man, with proper treatment following a sprain, ought to get around comfortably on his foot in a month. It was further ascertained that Mr. Allen Avery (since deceased) had paid claimant two different sums of money: one payment being \$5 and the other \$5, since the injury. Whereupon, it is hereby awarded, adjudged and decreed by Compensation Commissioner Donohue, that the respondent shall pay to the claimant forthwith compensation at the rate of five dollars weekly for four weeks, beginning on March 29, 1915, amounting to \$20.71, from which amount the \$11 already paid shall be deducted, leaving the amount to be paid to claimant \$9.71.

ASSESSORS MUST MAIL LISTS TO NON-RESIDENTS. New Law Puts Additional Work Upon the Board. One of the new laws passed by the last legislature will oblige the Norwich assessors to mail to non-resident property owners about 400 blank forms for the filing of tax lists. There are about 352 non-resident property owners, but some require two or more lists. The new state law on this subject is as follows: The assessors of real estate of tangible personal property located in any town more than seven months during the year, who are non-residents of such town, shall file lists of such real estate and personal property with the assessors of the town in which the same is located under the same provisions as apply to residents. The assessors shall mail to each non-resident or his attorney or agent having the custody of his taxable property, at least 15 days before the expiration of the time for filing lists, blank forms for filing lists of such estate or property.
