WASTY KILLED RAILROAD

Charles W. Chester, 66, Run Over Near Twelfth Street—Was on His Way to Work as Night Watchman at Warner Arms Corporation—Body Found by Men Walking Along Track.

Charles W. Chester, who lived at the corner of Fourth and Prospect streets, was instantly killed early Friday evening at the 12th street crossing of the New York, New Haven railroad. He was on his way to work as night watchman at the Warner Arms corporation building, just on the other side of the crossing. Mr. Chester met his sad end on his 66th birthday.

The body was discovered at 6.05 o'clock by several men who were walking up the track. One of them stumbled against something in the dark and lighting it with a lantern what it was discovered the terribly mangled body of Mr. Chester.

The south bound boat freight, which was on duty at 6.41, was probably the train that struck him as his watch stopped at 6.41. The whole train had gone over him, rolling the body of the building as if it were a toy so terribly mutilated and dismembered that parts of the body were strewn along the tracks for some distance.

Identification was made with difficulty and Dr. H. Brewster, who is acting as medical examiner, said that it was one of the worst cases he had ever seen.

The train that struck Mr. Chester had gone on without anybody aboard knowing that a man had been killed. The medical examiner was summoned to the spot and after viewing the body he gave permission for Undertaker Gager to remove it to his morgue.

The deceased was of a quiet disposition and well thought of by his employers. About 20 years ago he was engaged at the Shetucket mill and at one time he conducted a boarding house known as the Shetucket house. He had also worked for a number of years as a watchman in Plainfield, coming from there to this city. He had recently entered the employ of the Warner Arms corporation.

He is survived by his wife and by three married daughters, all residents of this city.

BAPTISTS PETITION. Ask For Pardon of Willis F. Walker, Formerly of New Britain.

The directors of the Connecticut state prison at a meeting held Thursday noon, received the petition from the pastor of William F. Walker, of New Britain, formerly treasurer of the convention and of the New Britain Savings bank, who has been in prison for nearly ten years on charges of embezzling nearly \$60,000 from these two institutions. The prison directors placed the petition on file, but took no action thereon, according to the report of the members of the board. It will probably not come up for action again until the next meeting of the board in December.

The petition was sent to the directors as the result of action taken by the board of trustees of the convention in October when it took no action to authorize the officers to send such a petition to the prison directors in the name of the convention. The petition was accompanied by a letter from the directors of the convention, asking for the request being made, but made it clear that the convention was entirely willing to have Mr. Walker set free. At that time the trustees petition it was said that the trustees were prompted to their action by the belief that the end of justice have already been accomplished in the case of the New Britain embezzler, that Mr. Walker is old, broken in health and penitent and that some of the stolen money has been recovered.

Likewise, the author also denies that any indemnity should be paid for lives or property lost on the Lusitania, and cites a prize court finding in the Franco-German war. A French court ruled that English, then neutral, owners of cargoes, which had been sunk by German ships could not collect damages. He also quotes the English authority on international law, Hall, who says that neutral owners of cargoes destroyed by acts of war have no valid claim for damages.

GERMAN OPINION ON SINKING OF LUSITANIA. Authorities on International Law Believe It Was Justifiable.

Breslau, Germany, Nov. 12.—The opinions of twenty-one of the most prominent German authorities on international law, who are few exceptions university professors, on the legal questions involved in the sinking of the Lusitania, have been collected into one volume, which is published and hailed as the consensus of German opinion in differing language but with unanimity the authors agree that the act of the submarine was justified.

As representative of all twenty-one, the Koestlinger Zeitung selected for publication and approving comment the opinion of Prof. Max Fleischmann of the University of Koenigsberg, who has written a comprehensive but concise introduction to the book, and extracts from the opinion of Dr. Karl Strupp of Frankfurt-on-the-Main.

Dr. Strupp begins by quotations from naval orders in the war of 1812, issued respectively to Lieutenant Allen of the American ship Argus and to Captain Stewart, the commander of the advantage of attacking the enemy's commerce, and the second directing the sinking of English vessels when there is any risk of their being rescued while en route to a port as prizes.

"It cannot be expressed more clearly," says Dr. Strupp, "that the North American government orders the destruction of enemy ships when they cannot be safely brought to a friendly port."

He then asks the question whether it is the duty of a war vessel to save the passengers and crew of an enemy ship, admitting in doing this the existing rules of international law apply to submarines. He declares they are to be suspended when military necessity, or even when serious need, arises.

The commander of a vessel, he says, must weigh the circumstances, and did so in the Lusitania case, and decided rightly that such need did exist for his little ship before the giant vessel of 4,000 tons, "which might at any time ram him, and which probably had concealed cannon on board, and perhaps even Canadian auxiliary troops."

"Above all," says Dr. Strupp, "it is settled that the Lusitania was an auxiliary cruiser, subsidized by the English government and carried as such in the English lists, which as a natural consequence meant that she was no longer a merchant vessel, but was to be regarded and treated as a vessel of war."

The submarine commander, continues Dr. Strupp, did not have to wait until his danger became acute. In case the destruction of the Lusitania was justified he was under no necessity to take
