Academy Was Founded Sixty Years Ago Today—Enrollment Has Increased From 80 to 600—Football Team Plays at Storrs.

At the morning exercises Friday, Principal Henry L. Tirrell spoke about the founding of the Academy. He mentioned the fact that October 21, 1916, was the sixtieth anniversary of N. F. A. He spoke of the steady growth of the school, since its opening, from eighty students to about six hundred. He eulogized Dr. Gulliver and those men who worked to start the Academy. He said that almost everything we enjoy we got through the sacrifice of somebody else, as well as by a sacrifice of our own. Eighty thousand dollars was subscribed to start and run the Academy. Since then many dollars have been contributed by public-spirited citizens, so that now students can attend N. F. A. with practically no personal expense. Contrary to general opinion the Academy is a private school, holding a charter from the state. He said that nearly everybody had an ambition, and that that aim should come before everything else, that pleasure and other things should be laid aside when they conflicted with duty, that a pupil's ideal should be to go as much from his studies as he could.

HON. LUTHER K. ZABRISKIE SURVIVED TERRIBLE HURRICANE
