WILL CASE HEARING EIGHT ALL Day Hearing Occupied Attention of Probate Judge on Wednesday—Dr. W. K. Tingley Testifies That Testator Was in Right Mind When He Signed Document—Edwin Wheeler Testifies Along Similar Line.

Testimony given at the afternoon session of the Dr. Nathan Johnson will hearing on Wednesday showed that the doctor was capable of making a will as his mental faculties were sound.

The testimony was not all given and adjournment was taken until Saturday morning.

Mrs. Sullivan was not in attendance at either the morning or afternoon sessions. Dr. W. K. Tingley's testimony was withdrawn on Wednesday and he will be called to the stand on Saturday morning.
