

R. W. CLACK WRITES TO Y. M. C. A. FROM CHINA Edwin W. Hill, secretary of the local Y. M. C. A., has received an interesting letter from R. W. Clack, the local association's representative at Paoingfu, China. Speaking of the North China meet at Tsuydantou, Mr. Clack says: There were over 300 contestants in the middle school class and almost 200 in the college, representing six different provinces. As last year Tsing Hua College, the American indemnity school was an easy victor in the college class. Peking Higher Normal taking second. Our local association was the largest Paoingfu point winner, when Teng, one of our educational secretaries, took second in the javelin throw. In the middle school class, however, with fifty schools entered our five Paoingfu schools finished first, second, fourth, seventh, and ninth, winning three-fifths of all the points, and Paoingfu boys, who not only broke the records in both mile and half mile, but ran the mile fourteen seconds faster than the college men. In the tennis tournament held in connection with the meet, two middle school boys, whom Hubbard has trained, beat all the college men, and won the doubles without the loss of a single set. After the meet thirty men were picked to go to Manila for the Far Eastern Games. Five of these were Paoingfu boys. One of them, however, was taken sick on the trip, and had to be sent back, so did not get to compete. The Peking basketball team was also taken along from the north. In Shanghai thirteen more men were picked for the track team from East China, and we were joined in Manila by the football, volley ball, tennis and swimming teams, all of whom came from South China. As was to be expected the Filipinos carried off the lion's share of the prizes. They won the track and field meet, breaking eleven records and tying one. The Chinese took second and broke two records, while the Japanese were a poor third, though they also broke one record. In swimming, volley ball, and basketball the teams finished in the same order, but the Chinese beat the Filipinos out of first place in football. The Japanese as usual took the marathon run, and divided the honors with the Filipinos in tennis. In baseball only Filipinos entered.

A FEW MINUTES' WALK FROM FRANKLIN SQUARE.

FEDERAL COUNCIL, CHURCHES OF CHRIST

New York, Sept. 25.—Asserting that "we must face frankly the fact that a most dangerous inter-racial situation now threatens our country," the federal council of the Churches of Christ in America made public here today a "constructive program" for protecting negroes against mob violence, bettering their condition, and removing the cause of racial troubles. The plan was formulated by the council acting in conjunction with a committee representing white and negro citizens from all sections of the United States. At a meeting of the committee held here recently a discussion of the racial situation took place and it was decided to issue a call to the citizens of the United States to act in conformity with the high ideals of democracy and Christianity in the present condition of strained relations between the races. The statement outlining the program is signed by Frank Mason North, president of the federal council, Albert G. Lawson, chairman of its administrative committee, Wilbur P. Thickfield, chairman of the committee on Negro churches, and Charles S. Macfarland, general secretary of the council.

The first paragraph of the program urges protection against mob violence. It follows: "The government, local, state and national, should impartially guarantee to all classes security of life and property. Mob violence is becoming a crowd habit. When life and property are ruthlessly taken, when men and women are lynched with no protection from officers or courts, law and order are trampled under foot. We call upon the pulpit, the press and all good people to create a public sentiment that will support necessary legislation for the enforcement of existing laws, that life, liberty and the pursuit of happiness may be equally secured to all classes."

"The negro should have economic justice, equal opportunity to get and hold work on the same terms as other men, with equal pay for equal work and with fair working and living conditions," the program continues. "The necessity of an immediate amicable adjustment of relations with white employers and fellow-workers."

Referring to crimes that provoke mob violence it is said: "We call upon men and women everywhere to protect the sanctity of home and womanhood. We record with satisfaction the growing enlistment of young leaders in a program of education and Christianization such as tends to prevent crimes that provoke mob violence. The home of the negro should be the same as that of other Americans, and the sanctity of his home relations should be safeguarded in every possible way. Swift and impartial action of the law should strike the violator of the sanctity of any home, white or black."

TWO ESCAPE DEATH WHEN TRUCK OVERTURNS

Thomas Barry and Benny Sands, members of the Indoor Circus company of New York, had a narrow escape from death Thursday morning when a big automobile truck capsized while attempting to make a sharp curve at the foot of Dudley hill in Mystic. Fortunately, both men escaped with severe and painful, but not fatal injuries. Barry and Sands were riding in a truck en route from Willimantic to Westbury, where the company's headquarters are. They were booked to play Thursday. The truck is owned by George J. Brown of Willimantic. The truck contained several pet dogs, a pony and several sheep. The truck was going down Dudley hill just as a touring car came up. The two machines met at a sharp curve at the foot of the hill, the touring car being close to the track. Barry, who was driving the truck, steered to the side of the road and the machine went along on two wheels for a distance of about 100 feet. The car failed to right itself and it crashed into a big elm tree beside the road. The car which weighed about a ton and a half and was top heavy capsized and the two men were buried beneath it. Barry and Sands were extricated a few minutes later and found to be severely injured, the former having lacerations of the face, head and body and a sprain of the left ankle and the latter having a fracture of the left thigh and bruises of the body. They were attended by Dr. A. H. Meyers of Mystic, who after giving emergency treatment, had the men removed to the Lawrence and Memorial Associated hospital in New London.

NO REFUND PRIOR TO LICENSE SURRENDER

In a letter addressed "to the mayors of cities and chairmen of boards of selectmen of towns where liquor licenses are issued," E. L. G. Hohenthal, chairman of the Connecticut prohibition committee, declares that no part of the license fee should be refunded for any period prior to the date of the surrender of the license. Mr. Hohenthal asserts further that it was never contemplated by the legislature to refund any fees for any period prior to surrender of licenses or certificates. A copy of the letter follows: "Pursuant to chapter 164, session laws of 1915, the attorney general of the state has notified the county commissioners that on July 25, 1919, it became unlawful to sell spirituous and intoxicating liquors under any license or club certificate issued by them, and holders of such licenses or certificates were, therefore, entitled to a refund of license money."

"I desire to direct your attention to section 2 of the act, which says: 'Upon the surrender of his license by any licensee or by the holder of a club certificate the commissioners shall reimburse such licensee or holder in an amount bearing such proportion to the total license fee paid as the unexpired portion of the license year bears to total period for which such license or certificate was granted.' The point I wish to emphasize is that no portion of the license fee should be refunded for any period prior to the date of surrender of the license. 'Towns are penalized to the amount of 10 per cent. for failure to pay the county commissioners, upon their request, license money received by your town. I suggest that you protect your town by bringing the matter to the county commissioners prior to their sending you their request. 'It was never contemplated by the legislature to refund any fees for any period prior to surrender of licenses or certificates. Further, as late as August 15, 1915, the attorney general refused to declare the sale of liquors unlawful, despite the fact that Judge Chatfield's decision, which is now quoted as au-
