INTERNATIONAL TRADE ILLS AND CURES

Atlantic City, N. J., Oct. 22.—Hundreds of the world's greatest business "surgeons"—men high in affairs in the United States, Great Britain, Italy and Belgium—met here today at the opening session of a three days "clinic" to diagnose international trade ills and prescribe their cures.

The International Trade Conference, as it is called, is being held under the auspices of the Chamber of Commerce of the United States. Among the notable names who are invited to speak are King Albert of Belgium, Herbert Hoover, A. C. Bedford, chairman of the board of directors of the Standard Oil Company, Sir Arthur Shirley Benn, M. P. England, Eugene Schneider, head of the Creusot works, the "steel king" of France, Florimond Hankar, director of the National Bank of Belgium and Fernando Quarleri, formerly head of the Italian delegation to the International Munitions Council.

Ten committees, named by an executive committee of which Mr. Bedford is chairman, are to submit surveys and reports on American trade and financial conditions for the information and assistance of the directors of the National Bank of Belgium and Fernando Quarleri, formerly head of the Italian delegation to the International Munitions Council.

Discussions of the objects of the Credit and Finance Committee, Mr. Alexander said, "it is to study the question of re-establishing normal trade relations between the United States and the nations of Europe, to provide an opportunity for the frank discussion of the facts and an exchange of views with our visitors from England, France, Italy and Belgium. Neither the foreign delegation nor the American committee is in any sense official."

"It is hoped that a discussion around the table of the facts and the principles involved may serve to expedite the re-establishments of sound credit conditions based upon a renewed understanding and confidence, and the steadily increasing production. The objective is to place foreign trade on a normal basis, and not, except so far, as the immediate emergency may demand, to utilize and perpetuate abnormal conditions by unusual methods."

"In other words, the committee's aim is to search out, with all possible speed consistent with soundness, the ways of re-establishing normal trade relations between the United States and the nations of Europe on a free carry on full trade relations with the United States along business lines, economically sound, commercially desirable and reciprocal, beneficial. These elements form the only basis for relations which can be permanent and which therefore will be regarded as desirable either by the nations of Europe or the United States."

"It is hoped that the better understanding of the needs involved and of the resources available to meet these needs, which are to be discussed here, will prove a forward step toward the adoption of a wiser and more natural sequence in business and financial communities of the world, of remedies sufficiently far-reaching to meet present difficulties and requirements."

While it is a fact that the delegates to the conference are not empowered to pledge their governments in any way, their recommendations are expected to carry great weight. The conference, it is said, has the "sympathy" of each nation represented. England, France, Italy and Belgium, as well as the United States, have attendance an official "observer," who will report to his government and, where such a course is desirable, is expected necessary "enabling legislation" will be passed to put the recommendations of the conference into effect.

Stabilization of foreign exchange is, perhaps, the most vital topic up for consideration. One delegate puts it: "We must stabilize exchange or we won't have any foreign trade at all. Europe needs vast quantities of raw materials, semi-finished as well as finished goods, and the United States has the storehouse of the world most extended credit to put Europe back upon an industrial buying basis."

Two recommendations will be made at the conference, among others, for the stabilization of exchange, one of an "international currency" by Marshall Stevens of England, one of the founders of the Manchester Ship Canal, and the other for a guarantee by American banks of foreign railroad and industrial securities to encourage their purchase by American investors.

Mr. Bedford, chairman of the board of directors of the Standard Oil Company, said that the woolen industry of northern France, before the war, competed for pre-eminence with the ruined or destroyed French textile mills. It is one of the big problems of the rehabilitation of France. The power fuel situation in France, Italy and Belgium is also pressing. Authorities say the world faces a coal shortage of 70,000,000 tons. England and America will distribute wisely their available export supply.

"As a result of the war, there were only two countries before the war who manufactured chemicals for export, America and Germany. With the present chaotic state of exchange, the French business men might be forced to swallow their objections of trading with the enemy and buy German chemicals because of great commercial need. The present point is that before the war closed the United States was producing 5,000,000 tons of sulphuric acid in its own home. One of our problems is to ascertain how these big war chemical plants can be adapted to the arts of peace."

It started with a parade at 4 p. m. from the Social club rooms headed by C. H. Truesdell in his automobile with Miss Alida Baribeau as Statue of Liberty and Dorothy Harvard as Dove of Peace. These were followed by Alice Baskley, Uncle Sam, Mrs. L. Garjepe as Columbia with a large American flag, Mrs. W. Austin as France with French flag, Mrs. T. Corcoran as Welcome to some girl and her daughter as Victory girl, both bearing American flags; Albert Hollin, president of the Men's club, in a general's full uniform, Mr. Alvord in police uniform heading the famous Independent Attawaugan and Ballouville Drum Corps. Then marched the brave World War veterans, followed by Miss Lornea Mathews of Dayville, Me., and the boys who served in the recent war, Mrs. A. Lameroux with the welcome flag and Miss Y. Alix in a military dress holding a gold star service flag with Louis Pechie in a khaki uniform, its one star representing Leo L'Homme who sleeps over there.
