

WESTERLY

Loren G. Waite, 47, was found dead on Tuesday morning before his motor truck, having died from suffocation. He was a market gardener on a large scale, who with his wife, Dr. Anna Langworthy Waite, connected the Waite farm, at Bradford. He had the rear end of the motor truck jacked up to do some repairs. The jacks were too short for his purpose and the timber striking the car in a lifting position, that he accidentally, while at work with a crowbar, struck one of the jacks, and the motor truck fell on top of him, crushing his chest close to his breast, and forcing him there. He died of suffocation—was choked to death.

Mr. and Mrs. Waite decided to work all Monday night in washing and preparing cauliflower and celery for the market. The timber striking the car in such larger quantity than usual, to meet the Thanksgiving patronage. The work was well advanced by ten o'clock, and Mr. Waite decided to get the car ready for use in the early morning, and to make repairs that were necessary. Mrs. Waite stating that she could complete the work in which she was engaged unaided by her husband.

Just after midnight, Mr. Waite went to the house on the farm where Mrs. Waite was at work, for a drink of water, saying that there was quite a job on the truck, but that he would have it completed by early morning. He then returned to the garage. Shortly before six o'clock, Mrs. Waite went to the garage. She called to her husband, receiving no response, she went into the garage, and called to him again. She took hold of the truck, which was cold, and realized the situation, she called Dr. Samuel C. Webster, the family physician, but Mr. Waite had been dead several hours. Dr. Webster, a specialist, medical examiner, was summoned, and the body was removed to the farmhouse.

His wife, Mr. Waite is survived by a son of sixteen. He was born in Orange, Mass., the son of Mr. and Mrs. James H. Waite. He was graduated from the Massachusetts Institute of Technology in the class of 1919, and soon thereafter was in the employ of the General Electric company at Lynn and Schenectady. He then came to Westerly and was employed for two years at the plant of the C. B. Cottrell & Sons company. By reason of failing health, he decided to leave the city and go to the farm, where he worked hard and by his industry and tenacity established a successful business. They were married in New York city in 1912.

Mr. Waite was state deputy of Pomona Grand, treasurer of the Quonsetpoint Grand, and a member of the executive board of the farm bureau. He acted for several years as minister of the Seventh Day Baptist church in Bradford.
