TEN LIQUOR CASES FOR U. S. COURT

It was shown by the county agent that the various communities were interested in poultry work; 1 in fruit; 2 in lime and clover; 3 in better dairy stock; 4 in cooperative buying; and all of the communities should be interested in better organization for farm bureau work. It was decided to group the lime and clover roughages, pasture improvement and better dairy stock under one head and call it the dairy improvement project. These five projects will be the basis of the farm bureau work during this year. This does not mean that each community must by any means adopt these projects, but that the information secured from the various communities thus far pointed to the fact that interest was centered in these five lines of work. In other words this program is based on what the various communities state that they want to see done, rather than on what the executive committee wants to see done. The executive committee is anxious to carry out the desired of the various communities of New London county in this program.

On Tuesday in the house at Hartford a resolution was introduced appointing John H. Barnes judge of the city court of Norwich, another resolution naming H. H. Pettis for judge and a third naming Mr. Pettis for deputy judge. On Wednesday in the senate a resolution was introduced appointing Frank N. Gardner judge of the city court of Norwich.

BETTER ORCHARD CAMPAIGN OPENED AT EAST LYME

The pruning demonstration which was to have been held the first of this month on Scott Bros' farm in East Lyme, but was postponed on account of bad weather, was held Tuesday afternoon. W. H. Darrow, the fruit specialist, and County Agent H. F. Johnson were present. Several young trees were pruned, particular emphasis being laid on the fact that after the first two or three years it is unnecessary to head any young apple trees and that only branches which are crossing or are too thick should be cut out. If heavy pruning is done after the first two years it simply promotes the growth of large numbers of water sprouts, which in their turn must be pruned out and is inclined to make bushy headed trees rather than one of desirable form for bearing fruit. The Scott Bros. are running their orchard as a demonstration orchard for the community of East Lyme. This is the first of the series of meetings which will be held in better orchard practice this year.
