

GERMANY'S COMPLIANCE TO ALLIED DEMANDS COMPLETE

Text of Acceptance by German Government Opens With Promise "to Carry Out Without Reserve or Condition Its Obligations as Defined by the Reparations Commission"—Lloyd George in Giving the Terms in the House of Commons Said: "There is Complete Acceptance of Every Demand."

London, May 11 (By the A. P.).—Germany's unconditional acceptance of the reparations terms was delivered to Prime Minister Lloyd George by Dr. Stresemann, German minister to Great Britain, here today.

Mr. Lloyd George announced in the House of Commons this afternoon Germany's complete acceptance of all the allied demands. His announcement was greeted with prolonged cheering.

Dr. Stresemann handed the German reply to the prime minister at 11 o'clock this morning and Lloyd George immediately telegraphed the news to all the governments concerned.

Owners Claim That Sailings Are Normal

Seamen Maintain That Departures of Coastwise Vessels Reduced 50 Per Cent.

New York, May 11.—Denying statements by marine union representatives, that departures of coastwise vessels have been reduced 50 per cent, officials of the Mallory, Clyde and Southern Pacific companies today declared sailings had continued at nearly normal since May 1.

The freight steamers El Valle and El Alba, of the Southern Pacific company, are on their way to Galveston, and the passenger ship Omnia is on the way to New Orleans, officials of that company said.

At the offices of the Clyde and Mallory lines it was stated one steamer has left for Galveston and three for Charleston and Jacksonville since the strike started.

Sailings of two shipping board freighters operated by the Mallory line between New York and Mobile were cancelled.

Clearances today at the United States custom house showed the names of eight American ships for foreign and coast ports.

Bert L. Todd, business manager of Local Union No. 89 of the Marine Engineers' Beneficial Association said the union is not doing the man foreign lines.

However, he said, it was expected, when the strike began, that it would take about three weeks to tie up coastwise traffic.
