

WESTERLY

A busy session of the Third district court was held Monday morning in the courthouse, when four cases were heard by Judge Oliver H. Williams.

The first case was that of Tryon Whitford, 23, and Earl Whitford, 20, colored, who were tried jointly on the charge of driving off the automobile of Francis H. Lindberg without the owner's consent. It was alleged that Lindberg, who lives in Bradford, was calling on friends in Pierce street Sunday morning and left his Maxwell touring car by the curb. When he came back to look for the car it was gone.

The Westerly police were notified about noon and the car was traced to Norwich. From that city the accused sped for New London, and when they had nearly reached that city the car skidded and was badly smashed up, while Mrs. Etta Wunch, white, who was in the rear seat at the time, was thrown through the top. The car was towed to Golden's garage in New London and the party hired another car to get back to Westerly. The police were on the lookout for them and they were arrested as soon as they arrived here.

They were represented Monday by Attorney Michael Turano and a plea of non-guilty was entered. The case was con-

tinued to Friday morning and bail in each case was fixed at \$1,000.

Mrs. Henrietta Wanch of 24 Dayton street was the next to be tried. She was arrested Monday morning by Officer Donald Ferguson and was charged with being a common prostitute and of being a lewd, wanton and lascivious person in speech and behavior. She pleaded not guilty and her case was continued to Friday morning, bail being fixed at \$500.

Paul Wunch, the husband of the accused in the previous case, was next brought before the court, charged with maintaining a common nuisance at 24 Dayton street. He also pleaded not guilty to the charge and his case was continued to Friday morning. Bond was placed at \$1,000.

The last case was that of Adolph Blinkits of East avenue, who was charged with committing a violent assault on Dr. M. H. Scanlon Saturday night. It was alleged that Blinkits had been drinking previous to the assault and that he had stopped a runaway horse on Canal street, suffering a kick in the right leg. The doctor was called to the garage on Canal street and administered treatment, after which he took the man to his home on East avenue and afforded him further treatment. When it came to the settlement of the bill it was al-

leged that Blinkits refused to pay the fee and threatened the doctor with a chair and stove poker, finally calling for his knife. The physician left hurriedly and notified the police, but it was not until late Sunday that Blinkits was apprehended.

He said that he couldn't remember much that happened that night, owing to his intoxicated condition, and pleaded guilty to the charge. He was fined \$10 and costs, amounting to \$12.80, which were paid.




