FOUND AT NOAK INN
Charges of violation of the anti-smuggling law and of the prohibition law were made against Lewis J. Webb of Hartford, who was presented before U. S. Commissioner Earl Mathewson in this city on Thursday morning after prominent officials had seized about \$1,600 worth of liquor at the Bay-side inn, Noank, last Wednesday night. Webb, who is owner of the Sigourney house in Hartford, is also alleged to be the owner of the inn at Noank.

He waived examination before the commissioner and was placed under \$2,000 bond to appear in the district court.

Chief Jonathan Eno and officers from New London and Willimantic made the raid on the Bay-side inn. Mr. Eno and some of the best and most complete lines of imported liquors seized in this state. All wet goods seized were of best quality, the best carried by rum running schooners from the Bahamas Islands.

A list of the liquors seized includes five cases of Seagram whiskey, six quarts of wine, five quarts of gin, five gallons of alcohol, one barrel of 3 per cent. beer.
