MOOSUP MILL STRIKE DECLARED OFF BY UNIONIZED WORKERS

(Special to The Bulletin) Danvers, August 18.—The strike of employees of the Aldrich Manufacturing company at Moosup has been declared off. This was announced Friday, following a meeting of unionized workers representing a small proportion of the normally employed at the plant.

At Moosup Friday afternoon it was stated that the vote of the unionized workers in favor of declaring the strike off was 15 to 2. It has endured nearly a year, running with 60 per cent. of its normal complement of 700 employees and gaining in the number of workers each day.

The end of the strike will be hailed with delight all through this section of eastern Connecticut. Competent and neutral observers regarded it from the first as an illadvised move and one for which there was no real excuse.

Therefore it lacked public sympathy and has failed to attract the sympathy of the public since June 28 and, has caused a loss of \$50,000 in wages to the striking workers as well as very serious losses to the mill company involved in the struggle.

It is expected that the plant will be operating next Monday morning with practically a full force of help.
