Angelo Manello, of Burnside, is suffering from severe cuts on the face and leg in St. Joseph's hospital, as the result of an accident in which he figured about 1:30 o'clock Tuesday morning. Manello was on his way to Storrs in a friend's automobile. He was rounding a curve on the Hartford road, just beyond the bridge, near Columbia, and gave the wheel too sharp a turn, causing the car to plunge into the state highway fence. Manello was thrown against the windshield which was broken and he sustained two deep cuts on both sides of his face. One cut practically severed his nose and extended down to his chin, preventing him from talking. Twenty-eight stitches were necessary to close the wounds.

During his residence there he was a constable, represented the town in the general assembly in 1883 and acted as agent for the humane society. In 1907 he located in Willimantic where he conducted a fish market. Later he retired and took up his residence in Andover. Mr. Deming was married twice to Emma C. Darling, and to Maude Smith. The latter, whom he married in this city in 1908, survives him. He was selectman in Andover.
