



Acting as a committee to whom this matter was referred for investigation, we would beg leave to report through the columns of your paper, the following well authenticated result. We would first remark, that to attention would have been paid the article referred to, believing it unworthy the notice of any being, however mean and degraded; but its nature, and the manner in which it was written, is an excluded member from a church in this city, for flogging and mischief-making, and other like offences, were it not for the explanations being made, and the persons designated to whom the whole matter is referred as the parties concerned by certain citizens of high pretensions, who make a business of coming and peddling scandal for the injury of their neighbors and the satisfaction of those who are ready to feast on the injuries and sufferings inflicted on the innocent, and revel in that infernal moral piracy, slander, practised on the character of the virtuous and valuable.
