CALIFORNIA.

Weather Report.

LATHROP, January 22nd.—The wind in the northwest, and the weather is clear and cold. The ground has been covered with snow for the last few hours. The snow is one inch deep this morning.

VISALIA, January 22nd.—Snow fell in Visalia last night, for the first time in ten years, to the depth of three inches. It is still covering the hills.

SANTA PAULA, January 22nd.—Nearly one inch of rain fell here yesterday. Snow fell in the Santa Clara valley—something that was never seen before by civilized man. The thermometer marks below the freezing point, and the ground is white with frost. The potatoes are entirely ruined, that is, that part which is up. Sheep are dying off in the foothills. It cannot be estimated at present to what extent orchards of semi-tropical fruits are injured, but it is sure that they have suffered.

MARCOPA (A. T.), January 22nd.—About 8 o'clock this morning it commenced raining, with a strong wind from the southwest. It continued to rain until 11 A. M., when the wind veered around to the west and snow commenced falling. At 5 P. M. there was over five inches of snow on the level.

SAN DIEGO, January 22nd.—The storm of the last 24 hours has now subsided, and the weather is clear and cold. The thermometer shows within 25 miles an even temperature. The thermometer this evening marks 40.

BAKERSFIELD, January 22nd.—After an all night rain commenced falling at 10 P. M. It is now an inch in depth, and still snowing—the first snow, with the exception of the snow in 1875, that has fallen in this city for fifteen years.

PORT TOWNSEND (W. T.), January 22nd.—Eight inches of snow fell in this city Monday night. It is a heavy frost night. Thermometer, 18°.

The Supreme Court Decides that Bills in the Legislature Must be Read Three Times.

SAN FRANCISCO, January 22nd.—In the case before the Supreme Court regarding the reading of bills in the Legislature, the Court this morning decided that the Constitution requires that each bill should be read three times at length, unless the first two readings be dispensed with by a majority of two-thirds of the members. The opinion will be filed in the case within a few days.
