THE CONVENTION.

Appearance of the Hall, Decorations, Etc.

TEMPORARY OFFICERS ELECTED. George F. Hoar of Massachusetts Chosen Chairman.

SELECTION OF THE COMMITTEES. Tilt Between Conkling and Frye in Regard to the Utah Delegation.

ADJOURNMENT UNTIL THIS MORNING. Speculation as to the Situation—The Feeling at Washington.

THE PLACE OF MEETING. CHICAGO, June 21.—The Exhibition building, in which the National Republican Convention is being held, presents a scene of striking interest.

At 12:30 the delegates are generally in their seats, but the galleries are filling slowly.

CHICAGO, June 21.—At five minutes after 1 the Chairman of the National Republican Committee called the Convention to order, and called on Rev. Dr. Kittredge, of Chicago, who opened the proceedings with prayer.

At the request of Cameron, Secretary Keogh read the call for the Convention.

CAMERON SPEAKS—TEMPORARY CHAIRMAN. Cameron briefly addressed the Convention, referring to the bitterness, which he hoped would now disappear in a desire and determination to put in nomination for President the strongest candidate, and one who would command the respect of the civilized world.

He concluded harmonious and united action. In conclusion, he announced that he had been instructed by the National Committee to put in nomination for temporary Chairman Hon. George F. Hoar, of Massachusetts. [Applause.]

The nomination was unanimously ratified. Davis of Texas, Frye of Maine and Raum of Illinois were appointed a committee to conduct Hoar to the chair.

Hoar, on taking the platform, addressed the Convention at some length. He arraigned the Democratic party for all the political sins committed by it, and said that that party confronted the Republican party to-day unchanged in purpose, in temper or in character, and united in nothing else—proposing no other measure of policy—than war on the safe-guard which the nation had thrown around the purity of elections. It saw nothing of evil except that a freeman should cast a free vote under the protection of the nation. [Applause.]

In Louisiana and Mississippi it was the accomplice of the White League and the Ku-Klux. In South Carolina it took the honest ballot from the box and stuffed it with fraud.

placed upon the roll. I have no right Mr. President, to speak of the merits, but whenever the motion in respect to Utah is in order I beg to be heard on the merits of that controversy. [Applause.]

The Chair is of opinion that the roll referred to in the resolution, which has been adopted by the Convention, is the roll prepared by the National Committee, and that the order of the Convention embraced in that resolution has been executed.

The Chair cannot hold, as a matter of order, that it is out of order to move now to call another Territory or State. [Loud applause and yell.]

Conkling—I will inquire of the Chair whether it is in order for me to move to amend the motion by adding as well the State of Louisiana.

Chair—Undoubtedly. Conkling—I do not make that motion, nor do I appeal from the decision of the Chair, but I beg to say that I desire to say to the Convention and to the gentleman from New York, that it was agreed by that committee that Utah should be put on the roll [great applause], and I desire to say further that the Secretary of the National Committee, standing right by me here, says he left out Utah by mistake. [Great applause.]

Now, sir, I take it that a Convention of Republicans is willing to rectify a mistake made by the Secretary. [Great applause.]

Conkling—I regret that the honorable Senator, the honorable gentleman from Maine, who is so able to make us all hear, should have made a motion utterly misleading, if what he now says is true, and I do not doubt that it is. That gentleman stated that there was a mistake in making up the roll, and he would have heard no more from me. [Applause.]

Conkling—Mr. Chairman, in reply to the gentleman from New York, I desire to say that when I made my motion I had just been informed that Utah had been left off. I know it was an agreement that it should go on. The Secretary was not near me for me to inquire. He came to me after my motion was made. [Applause.]

The Chair then directed that Utah be readmitted to the roll. [Applause.]

Richard McCormick of Arizona—I ask for the reading of the resolution that I sent to the committee a while ago.

The Secretary read the resolution, as follows: Resolved, That a roll of States and Territories be called for the presentation of credentials, and for notice of contest. All such papers shall be referred, without objection, or debate, to the Committee on Credentials.

The Chair then directed that Utah be readmitted to the roll. [Applause.]

When Utah was called, Senator Conkling rose to the committee on the roll of States and Territories, and said: "I beg to present the protest and the papers constituting that contest from that Territory."

The Chairman—That completes the call of the States and Territories.

On the call of the roll, Alabama and Arkansas gave notice of a contest.

Hendricks of Iowa gave notice of a contest in ten districts of Illinois. [Applause in the galleries.]

Warmoth notified a contest in Louisiana. Contests were also notified in Pennsylvania and Utah—the latter by Conkling of New York, by request.

The VETERAN ASSOCIATION ADMITTED. Logan of Illinois moved that instructions be given to the committee on tickets of admission to the Convention to issue 500 tickets daily to the Veteran Association; that justice had been done to the Veterans by every other National Republican Convention, and why should it not be done now and here? [Applause.]

There were veteran soldiers supporting each of the Presidential candidates, so that there was no particular move in his motion. He had to enter the building this morning without a ticket, because he could not get a ticket from the National Committee. He was here, and he wanted to see the Veterans also admitted—to make a noise or to cheer for any man, but to look upon the Convention which had nominated the man for whom they would have to vote. [Loud cheers.]

Kirkham of New Jersey seconded the resolution with all his heart.

The resolution was adopted. Conkling moved that as some of the committees already appointed could not report in time for an evening session to-night, the Convention take a recess until to-morrow morning at 11 o'clock.

Hall of Maine concurred in the usefulness of an evening session and favored Conkling's motion, which was adopted.

A recess was taken at 3 P. M. until to-morrow at 11 o'clock.

together, their plan being to tire out Blaine's adherents, in the hope of causing them to break in such a manner as to give the Grant men the power to control the nomination of a compromise candidate; but as Blaine's friends are by far the most earnest and enthusiastic of all the factions, the Grant fall is not likely to succeed in wagging the Blaine dog.

MISCELLANEOUS. Some shrewd calculators to-night estimate Blaine's strength at over 300 votes on the first or second ballot, while Grant's, according to present appearances, cannot be much larger on the first, and is likely to be considerably less on the second ballot.

Pixley, as Chairman of the consolidated Pacific coast delegation, is taking an active part in the proceedings, and the Credentials Committee have accepted his invitation to meet in the spacious California headquarters.

Exciting scenes are expected to-morrow when the committee report; but the Blaine men, while very firm, are conciliatory at all points, as if calmly confident of their own strength.

There still seems to be little confidence anywhere that Sherman or Edmunds can draw materially from the two leading candidates.

There continues to be much leaning towards Washington as the possible "dark horse," and some quiet work in some directions is doing for Garfield.

The Edmunds men are courting the Washburne sentiments by suggesting the latter for the second place on the ticket with their own favorite.

Frederick Billings is to put Edmunds in nomination.

THE COMMITTEES ON CREDENTIALS AND RESOLUTIONS. CHICAGO, June 21.—After the adjournment of the Convention the Committee on Credentials met and organized. Greene B. Raum, of Illinois, nominated for Chairman of the committee Mr. Tracy, of New York, and Wm. B. Chandler, nominated Omer B. Conger, of Michigan. Congressman Conger was chosen by a large majority. The anti-third-term men point to this as a significant vote, but the other side deny that it is indicative of relative strength.

The committee then took a recess until 5 o'clock, and is now in session at the Sherman House.

The Committee on Resolutions elected as its Chairman Hon. Edwards Pierpont, after which they heard an address from a delegate from the Woman's Suffrage Association, now in session here.

THE CREDENTIALS COMMITTEE AND THE ILLINOIS CONTEST. CHICAGO, June 21.—Rumor says the canvass of the Credentials Committee shows that they stand twenty-nine for admitting most of the anti-Grant contestants from Illinois.

REVIEW OF THE SITUATION. CHICAGO, June 21.—At 11 o'clock to-night the situation is as follows: The Committee on Credentials is still in session, and promises to have an all-night session. They have thus far decided only one case, which was that of Rapier (anti-Grant), from the Fourth Alabama District. It was decided by a vote of 31 to 12 to report in favor of admitting Rapier. This was the only vote in the committee, except that upon which Conger was made Chairman, being 29 to 11.

The committee briefly considered the cases of Smith and Warner of Alabama (contested), but they were passed for the time, and the Illinois case was taken up, Kirkham presenting it. This case will probably occupy the greater part of the session.

The Committee on Permanent Organization, by a practically solid vote, decided to continue the temporary officers as permanent. There was some agreement that Judge Hoar would be most satisfactory in that position to all parties.

There was a long meeting to-night of the Grant delegates and some other delegates, in all about 307. No definite information is received from them, but the general impression is that they decided to stand by Grant, and that the speeches were in favor of a strong support of that candidate.

The Grant men to-night claim over 300 on the first ballot, while their antagonists believe that he will fall below 290. This estimate is based on the belief that most of the anti-Grant contests will be admitted, and it is certain that the Committee on Credentials will report in favor of the admission of the Illinois delegation. From conversations with members of the committee, it is quite evident that the purpose is to take such action as the Blaine men also claim over 300 on the first ballot.

Edmunds appears to be growing slowly, and his friends now claim 60 votes on the first ballot for him.

It is reported on good authority that Chairman Cessa, of the Pennsylvania delegation, visited the Illinois headquarters, and on his own responsibility, but claiming to represent most of his delegation, offered to support the vote of Pennsylvania over to Edmunds and Harrison. The Indiana delegation did not discuss the matter seriously, as Harrison is said to object to the plan.

Sherman's friends present an unbroken front, and claim their candidate will receive over 100 on the first ballot, and that when the break comes he will be a general favorite.

The Kentucky delegation held a caucus to-day, and reaffirmed the resolution of their State Convention, which instructs them to vote as a unit. E. C. Hubbard, of the delegation, states that notwithstanding this action four of the delegates will
