Admiral at the National Capital.

WASHINGTON, June 2.—The river and harbor appropriation bill passed the Senate today without any change in the Pacific coast items heretofore reported.

Representative Page offered an amendment to the general deficiency bill in Committee of the Whole today, to appropriate \$7,000 for the payment of the California Deputy Marshals of Election. It was rejected by a vote of 50 against 44.

By threatening to raise the point that there was a vote of 50 against 44, Representative Page obtained an order that a vote by yeas and nays should be taken upon this amendment in the House.

Representative Davis, at the instance of the Bankers' Association of California, has today presented an order from the Secretary of War, directing that a Federal vessel be fired on the 17th inst. from all the forts in San Francisco harbor.
