REBEKA, November 28th.-About a quarter to 10 o'clock last evening a light was seen in the blacksmith shop of the Wales Consolidated works. Immediately thereafter a volume of smoke and flame issued from the top of the building, and the holding workers were soon in ashes. There was but trifling damage done to the shaft or underground workings. The building was destroyed by fire. About 50 cords of wood was also burned. The heavy timbers in the building were expensive, being principally of Oregon pine. The loss is estimated at nearly \$10,000. Superintendent Griffith says that the works will be reconstructed at an early day, the condition of the mine fully warranting the same. The night shift had gone below but a short time previous, and had not been seen for the tunnel and windlass erected on that level, in all probability all those under ground would have sufficed. The cause of the fire is supposed to have been purely accidental, having originated in the blacksmith shop, the forge having been used during the early part of the evening. The works were insured for only \$2,500.
