The alleged parties named, together with James Thurney, who acted under a power of attorney for Moses Friedman, tried to have Coe obtain an explanation of the property owned by the most and carrying the same to Levi by acceptance of a loan bid from Levi of \$4,076, and that Levi should pay \$27,323. In January, 1878, Moses Friedman brought suit in chancery against Coe, Altmann, Levi and the Third National Bank, and it was referred, and the referee finds that the charges set forth are substantially that \$21,211 out of the property has been properly accounted for, and recommends that suit be brought against the defendants for \$18,921 and interest.

It does not appear to regard the Chinese as a class, but rather as individuals, and it broadly declares the right of Congress to regulate the immigration of Chinese laborers. For Female Disease, any of the United States may deem it expedient to restrict the number of Chinese who may be admitted.

Early next week a proclamation will be issued by President Harrison, placing China on the same footing as Great Britain and other nations with the matter of port tonnage and the right of coastwise trade.
