THE ADMINISTRATION OF PRESIDENT HAYES

In a few days the Administration of President Hayes will be at an end. It has been one of great difficulty since the outbreak, but when the whole facts of the past four years are marshalled in evidence by the country that it has been successful and creditable one.

But before he is commended on this score it is necessary to consider dispassionately the extent and nature of the obstacles with which he was confronted, and above all to ascertain whether he received the support to which he was entitled from the men who have so resented his alleged infirmity of purpose.

It must be remembered that Mr. Hayes found himself almost at the beginning of his administration opposed by the Republicans in Congress. His Civil Service reform programme was regarded by them as an assault on their privileges.

His attempt to do away with public opinion was regarded on the side of the Executive, and they declared war upon his administration in the most uncompromising way.

The history of the long struggle between President Hayes and his party leaders in the Senate has not yet been written faithfully, but when it is candidly related the country will realize, perhaps for the first time, that it required no little courage and persistence in the President to face the storm which was thus lost upon him.

It is not too much to say that the country is indebted to him for the fact that he was not a "machine" President, and he subsequently he diverged from civil service reform principles, and recurred at intervals to the old methods, the marvel rather is that the concessions he made were so small, than that he should have made any.

When, however, we come down to the facts of his administration, we are compelled to acknowledge that it has had all the essential elements of success. He found the Republican party disorganized, shattered, tottering to its fall under the load of abuses it was carrying.
